1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

5. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 12 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

5.1. Scope of work:

Supply and Fit 1 x ZED motor limit Switch for existing roller shutter door motor

Contractors are expected to ensure that safety protocols are adhered to, and managing the flow of museum visitors. Any proposed construction activities should consider operational hours, public safety, and accessibility requirements.

All work should comply with applicable safety and environmental regulations, ensuring that the renovation meets the highest standards of quality and durability.

5.2 TECHNICAL KNOWLEDGE AND INFRASTRUCTURE

Iziko invites contractors with the requisite technical expertise in the Installation and repair work of roller shutter doors and motor, to submit quotes for the works outlined in the SOW and read in conjunction with pictures attached in Annexure B.

Contractors must demonstrate:

- Technical Competence: A strong understanding of the technical requirements.
- Infrastructure Management: The ability to work within an active museum environment, ensuring the safety and integrity of the building and its collections, as well as the smooth operation of the space during construction.
- The personnel doing the installation/repair work must possess the necessary trade or any form of a valid certification for the works

Completion report to be issued conforming with all applicable standards and the roller shutter tested and signed off

6.1. EVALUATION CRITERIA

Iziko promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organization and individuals who will be providing the service and the organizational capacity supporting the project team.

Iziko is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

- Firstly, the bidder will have to comply with eligibility criteria as per Table 1
- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 2) and the minimum threshold of **80** points. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Proposals will be evaluated on the 80/20 preference points scoring system: that is, 80% of the points awarded will be based on price, as indicated in the table below; and 20% of the points awarded will be based on specific goals, allocated as indicated in the table below:
