1. PURPOSE

Nongoma Local Municipality seeks to source a panel for car hire services, as and when required for a three (3) year period.

2. AVAILABILITY

The service provider should be available under urgent conditions and provide vehicles even under emergency conditions.

3. DURATION

The duration of the contract shall be the minimum of three (3) years from the date of appointment.

The service provider will be evaluated based on performance atleast twice a year and prior arrangement will be made regarding such evaluation date.

4. EVALUATION OF THE BID

The following evaluation method will be used:

- After the closing date of the bid invitation, an appointed bid evaluation committee of Nongoma Local Municipality will evaluate the proposals of the bidders.
- The committee will individually evaluate each of the bid proposals received against the approved criteria as stated below.
- All proposals submitted will be evaluated on two (2) categories:
 - Functionality (technical content)
 - Specific goal

Bids are evaluated in accordance with the Preferential Procurement Policy Framework Act (MFMA), using the 80/20 split.

The evaluation of the bids will be conducted in the following two (2) stages:

Firstly, the assessment of functionality must be done in terms of the evaluation criteria and minimum threshold value of **75 points**. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.

During phase two, only the qualifying bids are evaluated in terms of 80/20 preference points systems. 80 points will be used for price only and the remaining 20 points are used for specific goal.

For functionality, the following criteria will be applicable and the maximum value of each criterion is indicated as below:

The points associated with the comprehensive proposal/profile will be awarded as reflected in the following table. Bidder **MUST** submit proposal.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

Certificate of Independent Bid Determination

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
