BACKGROUND: Cold Room has been non-functional for a year but needs to be assessed and repaired since we are in need of additional storage space at 4°C. Cold room 3 is currently still functioning but the temperature recently exceeds the set temperature of 4°C by 4-5 degrees way too often, therefore the unit needs to be assessed and serviced.

PURPOSE: To inspect and assess the non-functioning Cold Room 1 as well as Cold Room 2, and to quote for repairing /servicing and re-gassing of the two cold rooms.
