1. AIM OF PROPOSAL

1.1. The purpose of this project is to appoint OHS Audit Supplier for OHS compliance.

2. QCTO BUILDINGS SIZE (BUILDING A & BUILDING B)

- The QCTO has one site situated in Hatfield, Pretoria which consists of two buildings (Building A and Building B)
- 2.2. The size for building A is 3950.07 m2 and for building B is 1528.92 m2 and the total for the two buildings is (5,478 m2)

3. SCOPE OF WORK AND DELIVERABLES

- 3.1. The service provider shall audit QCTO Rules and Regulations charts
- 3.2. The service provider shall audit QCTO first aid boxes and the first aid kit to see if its line with OHS Act
- 3.3. The service provider shall audit QCTO health equipment and activities
- 3.4. The service provider shall audit QCTO if complying in line with new trends of OHS compliance
- 3.5. The service provider shall audit any possible and health and safety risks
- 3.6. The service provider shall generate an OHS audit report and advise
- 3.7. The service provider shall identify both strengths and weaknesses in the OHS program of a workplace,
- 3.8. The service provider shall audit QCTO accountability, policies, hazard identifications, control, training, and numerous other factors about OHS

4. MAINTENANCE AND SUPPORT

The QCTO intends to enter a once-off-service supply with the potential Service Provider to be appointed.

8. EVALUATION CRITERIA

QCTO may request additional information, clarification, or verification regarding any information contained in a tenderer's proposal. This information will be requested in writing, and the bidder must provide the requested information within forty-eight (48) hours after the request has been made; otherwise, the bidder may be disqualified.

QCTO may conduct due diligence on any bidder, which may include interviewing customer references or other activities to verify a bidder's or related information and capabilities and, in these instances, the bidders will be obliged to provide QCTO with all necessary assistance and/or information which QCTO may reasonably request and to respond within the given time frame set by QCTO;

The 80/20 principle will be applied in terms of the Preferential Procurement Policy Framework Act.

Each criterion will be assessed and scored on the evaluation sheet using the above points.

Threshold: Bidders who score less than <u>70 out of 100 points on functionality will not be considered</u> for Price and Specific goals and will be disqualified for this project.

Shortlisted bidders may be required to host QCTO for a site visit.

8.2. Stage 2: Price and Specific Goals

Only bids that achieved the minimum qualifying score/percentage for functionality will be considered further in terms of the **80/20 preference point system**.

The formulae to be utilised in calculating points scored for the preference point system will be included in the tender document.

Step 1 will be the calculation of points for price, where the lowest bid will score 80 points for price, while bids with higher prices will score lower points for price on a pro-rata basis.

The following formula will be utilised to calculate the points for price in respect of tenders with a Rand value below R50 000 00 (all applicable taxes included): $Ps = 80 \left[1 - \left(\frac{Pt - P \, min}{P \, min} \right) \right]$

Where:

Ps = Points scored for the comparative price of the proposal or offer under consideration;

Pt = Comparative price of the proposal or offer under consideration; and

Pmin = Comparative price of lowest acceptable proposal or offer.

Step 2 will be the calculation of points for the Specific goals contribution, where 20 points will be awarded to a Bidder as per the table below:
