a. Overall Dimensions and Height

The maximum loading capacity is required, and the trailer body design must take into consideration all legal requirements.

b. **Legal Towing Limits**

The maximum weight that a vehicle can safely tow is specified by the Bus Manufacturer. This is the safe towing limit for the vehicle and must not be exceeded – refer to **Addendum: A** – MAN Automotive Trailer Towing Limits for detail. PRASA will test the design specifications with the OEM specifications before the order is placed.
