1. INTRODUCTION

The SADPMR listed as a schedule 3A public entity in terms of the Public Finance Management Act (PFMA). In terms of paragraph 55 of the PFMA, Accounting Authority of the public entity must prepare financial statements for each year in accordance with generally recognised accounting practices as approved by the Accounting Standard Board.

2. OBJECTIVE

The SADPMR uses the Pastel Evolution financial system to record and report financial transactions. The system is currently supported by a Sage Pastel registered dealer which also advises the ICT on the Development of the Web Based Admin modules created to integrate with Pastel Evolution. The Support is needed for correction of Pastel data errors which happens from time to time. SADPMR has also benefited from the use of their expertise to align the communication between the web and Pastel.

3. DELIVERABLES

Sage Pastel maintains a list of registered dealers and value-added reseller for the software.
