The South African National Roads Agency Limited (SANRAL) hereby invites service providers for inclusion on the SANRAL'S panel of service providers to provide knowledge and compliance training services to SANRAL employees as and when required for a period of three (3) years.

Only respondents who are registered on the CSD at the submission closing date and meet the mandatory technical requirement as stated in clause 4.1 of the Submission Data are eligible to submit an expression of interest.
