Minimum Requirements:

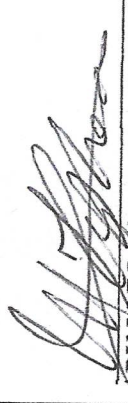
1. Price (s) quoted must be valid for a least thirty days from date of offer
2. Price(s) quoted must be firm and inclusive of VAT
3. Bidders must submit Certified copy of the CK1 or CK2 or any form of company registration with CIPC.
4. A valid SARS Tax Clearance Certificate / the tax compliance status pin to be submitted.
5. Municipal rates & taxes account not older than 30 days or Valid lease agreement must be attached.
6. The National Treasury Central Supplier Database registration report must be submitted.
7. Bidders must submit Company Profile and References
8. Qualifications and Experiences should be attached.
9. In order to claim preference points for specific goals. 1. **locality** –Where the tenderer is the owner of the property of the company, shall submit a Municipal rates and taxes registered in the name of the tenderer, where the tenderer is not the owner of the property of the company (A valid lease agreement or Affidavit from the property owner that the address used to claim points is being rented out to the tenderer) 2. **Youth / Race** – The bidders must submit ID documents for them to be able to claim points. **Bidders who fail to submit the relevant documents will not get 20 points**
