- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as RAL may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

#### **TERMS OF REFERENCE**

#### 1. INTRODUCTION

Roads Agency Limpopo SOC Ltd (RAL) is a provincial road infrastructure delivery entity registered under the Company's Act of the Republic of South Africa. It has been established under its constitutive Act, the Northern Province Roads Agency Act and Provincial Roads Act 7 of 1998. RAL started operating in 1999/2000 financial year. Its main functions are planning, designing, construction, maintenance, and control of the provincial road network. It owns and manages all the provincial roads, except municipal roads and National Roads. RAL is managed by the Chief Executive Officer who reports to the Board of Directors. Members of the Board are in turn reporting to the Shareholder, who is the MEC for Limpopo Department of Public Works, Roads and Infrastructure.

#### 2. BACKGROUND

Roads Agency Limpopo (SOC) Ltd seeks to appoint a suitably qualified, reputable and experienced service provider for maintenance, repair and replacement of parts for the UPS Equipment at RAL offices.

#### 3. PROJECT SCOPE

Ensuring that the UPS unit is in normal operating mode, with no active irregularities hindering the operation of the device and limiting the ability to deliver continuous clean power to the critical load. This shall be done through visual and mechanical inspection.

The maintenance service shall be done **quarterly**, through visual and mechanical inspection.

#### 4. SCOPE OF WORKS

- 4.1 The service provider must ensure that the UPS unit is in working order with no active irregularities hindering the operation of the device and limiting the ability thereof to deliver continuous clean power supply to the critical load.
- 4.2 To ensure the machinal soundness of the UPS unit; the service provider shall check, confirm, repair and/or replace, where necessary, all parts including but not limited to:
  - (i) Semi-conductor power devices, transformers, filter elements and other related parts.
  - (ii) Voltage of the DC (Direct Current) circuitry, including necessary adjustments.
  - (iii) Voltage of the AC (Alternating Current) circuitry, including necessary adjustments.
  - (iv) AC filter caps
  - (v) Electronic regulating circuits, including necessary adjustments.
  - (vi) Loose connections, hot spots and terminal corrosion of the batteries.
  - (vii) Load currents and voltages
  - (viii) DC capacitors.
  - (ix) DC caps.
  - (x) AC filter and ringing capacitors.
  - (xi) Fan operation.



- (xii) Cleaning of the UPS and battery system
- (xiii) Battery discharge test
  - ✓ Initiate a battery discharge test by failing the rectifier input to the UPS.
  - ✓ Inspect battery loose connections, hot spots and terminal corrosion.
  - ✓ Continuously monitor the DC voltage and discharge current.
  - ✓ Upon completion, return to the rectifier and confirm that the batteries are charging by measuring the DC voltage and charging current.
- (xiv) Visual checking for Hot Spots (discoloring of power wires and main bus bars)
- (xv) Confirmation of the Electrical Installation;
- (xvi) Checking of load currents and voltages;
- (xvii) Checking of environmental temperature and the ensuring that it is within the UPS operational specifications;
- (xviii) Checking and recording the voltage of each battery block on a log sheet;
- 4.3 A detailed service report must be submitted to RAL personnel after completion of the service with completed job card of work done.
- 4.4 All logged calls should be responded to (i.e. dispatch a technician for assessment) within two (02) working hours of such a call.
- 4.5 All identified faults should be attended to and fixed within six (06) working hours of such report. Where this is not possible due to non-availability of parts/spares, a report shall be communicated to the responsible RAL personnel; Thereafter 3.6 shall apply.
- 4.6 The appointed bidder shall provide an alternative UPS equivalent to equipment at RAL.
- 4.7 Maintain a reasonable level of stock for general parts and consumables. All parts and consumables shall be supplied with manufacturer warranty, guarantee, surety certificate (Not less than 3 years);
- 4.8 Supply all necessary consumables/materials;
- 5.9 The bidder shall always, prevent the accumulation of waste material, garbage, rubble and shall have same removed immediately from the premises;

#### 5. Special Conditions

- 5.1 All materials, machinery and equipment to be furnished and/or used shall be of the required quality and standard as approved by the South African Bureau of Standards (SABS);
- 5.2 Remedial work/repair or replacement of parts shall only be done after the submission of a quotation and official purchase order has been issued by RAL.
- 5.3 The successful bidder shall ensure that all key personnel will produce the relevant documentations in line with mandatory and functionality requirements; and produce proof of identity prior commencement of work.
- 5.4 The workmanship, method of installation as applicable shall be established by the Electrical Contractors Association of South Africa (ECASA);
- 5.5 The successful bidder shall sign a Service Level Agreement with RAL.
