SUPPLY AND DELIVERY OF LOW BED SEMI-TRAILER.

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for supply and delivery of low bed semi-trailer.

The tender document and specifications are available and will ONLY be sold at a non-refundable fee of R500.00 from the 22nd of April 2025. Tender documents will be sold @ Govan Mbeki Main Offices (Cashier's point) and no EFT will be allowed.

The closing time for receipt of quotations is **12:00hrs on 02nd May 2025**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all quotations will be public.

Completed documents, clearly marked "Tender No: **8/3/1-05/2025**" **Supply and delivery of low bed semi-trailer.**" with the "**NAME of SUPPLIER**" must be placed in a sealed envelope and placed in the tender box at Secunda Head Office, Horwood Street, CBD Secunda, 2302 by no later than 12H00 on **02/05/2025**. The envelope must be endorsed with bid number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of specific goals on a competitive basis for successful bidders on this tender. Govan Mbeki Municipality Supply Chain Management Policy allocate 20 points to:

- Race (6)
- People with disability (4)

- Youth (4)
- Women (4)
- Implementing reconstruction and development programme (2).

No awards will be made to a person:

- Who is not registered on the Central Supplier Database
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any quote or to accept a part of it. The municipality does not bind itself to accepting the lowest quotation or award a contract to the bidder scoring the highest number of points.

The following documents must be attached as Annexure (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Copy/ printed valid Tax Compliance status pin to enable the municipality to verify the bidder's tax compliance status - Compulsory**
- **Copy of company's municipal account and all its directors (not older than 3 months and not in arrears for more than months-90 days) or copy of a valid Lease Agreement – Compulsory**
- **Valid and Compliant CSD report, as at closing date of the tender – Compulsory**
- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
