DESCRIPTION: PROVISION OF BANKING SERVICES FOR A PERIOD OF 5 YEARS

Phokwane Local Municipality hereby invites prospective service providers to submit tenders for the Provision of banking services for a period of 5 years.

This BID will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations, 2017 pertaining to the PPPF Act (No 5 of 2000) and the Supply Chain Management Policy of Phokwane Local Municipality. Phokwane Local Municipality is not bound to accept the lowest bid or award a contract to the bidder scoring the highest points.

The tender documents are downloadable from the municipal website (www.phokwane.gov.za) and ETender portal. The closing date for submissions is **28 July 2022 at 12h00**. Bids will be opened in public immediately after the stated closing time.

TERMS OF REFERENCE

1. OBJECTIVES

To invite the banks to submit the proposals for the appointment of a banker for the PHOKWANE LOCAL MUNICIPALITY (the municipality). Any local Institution registered as a bank in terms of the Banks Act, 1990 (Act No. 94 of 1990) may submit a proposal.

2. SCOPE OF WORK

(a) Cash Management

- A current (cheque) account will be opened with the banker. The current account will be the Primary Bank Account of the municipality;
- Service fees and escalations. The banker must be able to identify all service fees on bank statements to enable the municipality to verify the charges for the different service fees charged. The banker must indicate the date of the first escalation in the Bid and annually submit the escalation fees to the municipality for consideration;
- Cash deposit fees that will be charged for any deposits made;
- Fees charged for R/D (Refer to Drawer) cheques. The banker must supply the municipality with information of these cheques to enable the municipality to claim the money from the debtor. The response time to this information should be stated;
- Fees charged for post-dated cheques;
- Rate of interest payable on credit balances;
- Banker must be able to handle a large volume of transactions;
- The identifications of electronic transfers/deposits to the account of the municipality are of utmost importance;
- The banker must be able to supply the municipality with information pertaining to debits and credits on this account;
- Deposit identifiers will be installed on these accounts to prevent payments with incorrect references. Available controls to limit unallocated deposits should be explained thoroughly to the municipality as a control measure;
- Electronic banking services to be provided must be stated;

- Cash management facilities must be clearly stated. Account information must be available electronically for the municipality and the electronic downloading of bank statements must be possible;
- The municipality must be able to do electronic stop payments;
- Electronic creditor payments must be available;
- The Information Technology must be compatible to the E-Venus financial system and VIP payroll systems being utilised by the municipality;
- The banker must provide the necessary training to use the electronic systems. The cost of training must also be included in the quotation;
- The period of historic information available on the system must be indicated;
- The short-term overdraft facilities and lending rate must be stipulated in the quotation;
- The banker must indicate their commitment to provide loans to the municipality. The particulars on the call loans / bridging finance should be stated;
- The branch of the banker where the account is opened must assign officers/client managers to banking handle the account, correspondence, queries, etc.; arrangements,
- The banker's commitment to assist the municipality in identifying any irregularities must be indicated;
- The banker must be committed to a quantifiable escalation. The annual increase will be limited to a maximum of CPIX rate;
- The banker must provide a solution on the petrol cards for the vehicles of the municipality. The municipality have +/-27 vehicles currently running and;
- The banker must provide a solution for administration of Home Loan Payments of employees.

(b) Revenue Collection enhancement

- The possibility to handle payments directly via the web page of the municipality must be stipulated.

(c) Social upliftment

Quantifiable and measurable details of the tenderer's intended contribution to the social upliftment within the municipal boundary must be clearly stipulated. The reference should include the following:

- Community projects;
- Financing initiatives to lower income groups for employees;
- Enterprise development (SMME access to finances);
- Financial Education workshops for EPWP contractors;
- Job creation in the district;
- Community based HIV/Aids programmes; and
- Customer care training for employees.

NB: Future initiatives ONLY and not what the banker has done in the past.

TECHNOLOGICAL CAPABILITIES

Details supporting their capabilities in the following areas:

Electronic Payments/Collections

- a) The bidder must have an **EFT function that directly connects to the municipality** (IP to IP Protocol).

Electronic Cash Management

- a) Account Information
 1. The bidder must install an on-line electronic banking system which is in line with security policy of the municipality e.g. frequent changing of passwords, and provide the necessary training;
 2. The bidder must provide the ability for archiving facility for the duration of the contract;
 3. An indication must be given as to whether the bidder is able to provide information that can be accessed online the same day, e.g. deposits, cheques, payments, transfers etc.
 4. The bidder must indicate the ability to provide the sorting facility of the online electronic bank system e.g. description of transaction, date, amount etc.
 5. An electronic tracing facility must be available whereby the cheque process date and amount can be verified in real time and have an online photographic image of all cheques;
 6. Reports of EFT transactions to be provided electronically on a daily basis;
 7. Online facility must provide for detailed audit trails;
 8. Telephone assistance should be made available during office hours regarding account enquiries;
 9. The municipality must be able to stop payments electronically;
 10. Access times in respect of all transactions to accounts held with the bidder as well as transactions to accounts with other commercial banks must be indicated; and
 11. The security aspects of the online electronic banking system must be indicated.

Bank Statements

- a) Electronic bank statements – the bidder must provide the municipality with daily information in an electronic format of all transactions that interface with the municipality’s accounting system for reconciliation purposes;
- b) The successful bidder must provide printed bank statements together with supporting documentation, for all accounts held with the bidder at least once a week;
- c) The municipality must be able to download bank statements electronically;
- and d) detailed bank statements charges must be supplied.

Bureau Service

- a) The bidder must have a bureau service which will enable the municipality to send and receive payment in batch format e.g. the electronic payment of salaries and creditors.
- b) All accounts must interface electronically with the municipality’s accounting system.

Cheques

- a) Own pre-printed cheques and deposit books must be held for safekeeping at the bidder and must only be released or issued to authorized personnel of the municipality.
- b) The bidder must have the ability to identify cheques that have been tampered with and fraudulently negotiated and be able to rectify such fraudulent actions at the earliest possible time.
- c) Provide a method for the withdrawals of petty cash when the cheques are crossed “not negotiable and not transferable”.
- d) The bidder must be participant in the cheques verification system where lost or stolen cheques and closed accounts are automatically updated.

Transitional Arrangements and Training

- a)** An indication must be given as to whether the system will operate from a stand-alone PC with a dial up connection or whether it can be accessed from the internet.
- b)** An indication must be given regarding the registering of the operators and limiting their access levels on the system.
- c)** Training must be provided to the officials on the electronic banking system.
- d)** Immediate assistance regarding problems with the system (ill-call centre) must be provided.

General requirements

- a)** A detailed monthly statement of bank charges and penalties are required; **b)** Enquiries must be dealt with within 24 hours;

- c) The bidder must provide proof of financial stability and a positive financial position and performance of their institution;
- d) Bidders must be able to assist the municipality in compliance to the applicable requirements of the MFMA in every respect; and
- e) Bidders should detail their experience in handling similar accounts.

3. GENERAL INFORMATION TO COMMERCIAL BANKERS

The Commercial Banking Service shall begin no later than 01 December 2022 or nearest date.

3.1 CLARIFICATION OF THE RFP (Request for proposal)

- i. At any time before the submission of the proposal, the municipality may, for any reason, whether at its own initiative or in response to a clarification requested by an invited firm, modify the RFP document by amendment. The amendment will be sent in writing by facsimile or electronic mail to all banks that requested proposal documents which will be binding on them. The municipality may at its discretion extend the deadline for the submission of the proposals.

3.2 PREPARATION OF PROPOSAL

Technical/Specification Proposal

In preparing the technical proposal of the document, bidders are expected to examine the documents comprising the RFP in detail. Material deficiencies in providing the information requested may result in rejection of a proposal as non-responsive.

Pricing Proposal

In preparing the cost/pricing proposals bidders are expected to examine the documents comprising this RFP in detail. Please ensure that all pricing is captured clearly in the pricing schedule provided.

3.3 PROPOSAL EVALUATION

PRICE SCHEDULE OF SERVICES – ANNEXURE A

Bidders are requested to quote firm prices effective from 01 December 2022. The pricing shall be fixed for five (5) years inclusive of the yearly price increases at CPI index. The total cost must include all costs applicable to implementation on new banking systems and procedures, including the cost of training Phokwane Local Municipality staff, computer software and hardware etc. and must be shown separately from transaction costs per year.

Bidders must use Statistics South Africa CPI index, which shall be used for calculating any future annual price increases on the dates of annual review. CPI applicable will be the annual inflation rate published for **October** annually by Statistics South Africa.

Price structuring will be a major factor in determining the suitability of the bidder regarding the various aspects of the commercial banking services provided. Prices must be set out on a separate schedule, and under the heading: "Price schedule of quantities of services to be rendered per year."

Bidders must ensure that their pricing covers all relevant banking services required by Phokwane Local Municipality.

The evaluation of this bid will be conducted in the following two (2) stages:

Firstly, the assessment of functionality will be done in terms of the evaluation criteria and the minimum threshold. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.

Thereafter, only those qualifying bids will be evaluated in terms of the 80/20 preference points systems, where the 80 will be used for price **ONLY** and the 20 for points awarded for **B-BBEE status level of contribution**.

Only service providers that can demonstrate the required experience and skills relating to the execution of this project will be considered. The following criteria will be taken into account for appointment of a successful service provider:

- a) All bids that do not submit valid tax clearance certificate or status verification PIN.
- b) All bidders that did not submit proof of registered as a Bank in terms of the Banks Act, 1990 (Act No. 94 of 1990).
- c) All bids that do not submit proposed work plan including Social Upliftment Programmes.
- d) All bids that are received late will be disqualified.
- e) All bids that are faxed e-mailed or telegraph will be disqualified.
- f) Failure to complete all required bid documents

1.2: TENDER CONDITIONS AND INFORMATION

1. General and special conditions of contract

The general conditions of contract (GCC) as well as special conditions of contract (SCC) forming part of this set of tender documents will be applicable to this tender in addition to the conditions of tender. Where the GCC and SCC are in conflict with one another, the stipulations of the SCC will prevail.

2. Acceptance or Rejection of a tender

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept part of it. The municipality does not bind itself to accepting the lowest tender or the tender scoring the highest points. The municipality reserves the right to waive any requirements as contained in the bid conditions and or specifications.

3. Validity Period

Bids shall remain valid for ninety (90) days after the tender closure date.

4. VAT

Price(s) quoted must be firm and must be inclusive of VAT.

5. Registration on central supplier database

It is expected of all prospective service providers who are not yet registered on the central supplier database to register without delay on the prescribed form. The municipality reserves the right not to award tenders to prospective suppliers who are not registered on the database.

6. Completion of Tender Documents

- a) The original tender document must be completed fully in black ink and signed by the authorised signatory to validate the tender. Failure to do so will result in the disqualification of the tender.
- b) Tender documents may not be retyped. Retyped documents will result in the disqualification of the tender.
- c) The complete tender document must be returned. Missing pages will result in the disqualification of the tender.
- d) No unauthorised alteration of this set of tender documents will be allowed. Any unauthorised alteration will disqualify the tender automatically. Any ambiguity has to be cleared with contact person for the tender before the tender closure.

7. Compulsory Documentation

7.1 Tax Clearance Certificate

- a) A copy of a Tax Compliance Status Pin or a Tax Compliance Certificate, printed from the South African Revenue Service (SARS) website, must accompany the bid documents. The onus is on the bidder to ensure that their tax matters with SARS are in order.
- b) In the case of a Consortium/Joint Venture every member must submit a separate Tax Compliance Status Pin and a Tax Compliance Certificate, printed from the SARS website, with the bid documents.
- c) If a bid is not supported by a Tax Compliance Status Pin and a Tax Compliance Certificate as an attachment to the bid documents, the Municipality reserves the right to obtain such documents after the closing date to verify that the bidder's tax matters are in order. If no such document can be obtained within a period as specified by the Municipality, the bid will be disqualified.
- d) The Tax Compliance Status Pin will be verified by the Municipality on the SARS website.

7.2 Municipal Rates, Taxes and Charges

- a) A copy of the bidder's (in the name of the company and/or lease agreement) and / or those of its directors municipal accounts (for the Municipality where the bidder pays his account) for the month preceding the tender closure date must accompany the tender documents. If such a copy does not accompany the bid document of the successful bidder, the Municipality reserves the right to obtain such documents after the closing date to verify that their municipal accounts are in order.
- b) Any bidder which is or whose directors are in arrears with their municipal rates and taxes or municipal charges due to any Municipality or any of its entities for more than three months and have not made an arrangement for settlement of same before the bid closure date will be unsuccessful.
- c) If a bidder rents their premises, proof must be submitted that the rental includes their municipal rates and taxes or municipal charges and that their rent is not in arrears.

- d) In the event of residing at the rural area where services are not rendered a letter from the tribal authority with affidavit must be submitted.
- e) Must be current municipal account.

8. Compulsory statutory supporting documents

- a) Certified copies of Identity Documents of members / shareholders / directors of the company (original stamp not older than 3 months).
- b) Valid CIPC documents / copies of company registration documents.
- c) Declaration of interest forms duly completed (MBD documents).
- d) General conditions of contract must be properly signed.
- e) Local content documents to be complete (when applicable)

9. Conditions

Comply with conditions as specified in the Bid documents and / or specification documents.

10. Quotation

- a) Specifications must be disclosed on the quotation.
- b) Quotation must be properly signed and must be on the company's letterhead.

11. Site / Information Meetings

- a) Site or information meetings, if specified, are compulsory. Bids will not be accepted from bidders who have not attended compulsory site or information meetings.

12. Samples

Samples, if requested, are to be provided to the Municipality with the tender document or as stipulated.

13. Quantities of Specific Items

If tenders are called for a specific number of items, the Municipality reserves the right to change the number of such items to be higher or lower. The successful bidder will then be given an opportunity to evaluate the new scenario and inform the Municipality if it is acceptable. If the successful bidder does not accept the new scenario, it will be offered to the second-placed bidder. The process will be continued to the Municipality's satisfaction.

14. Submission of Tender

- a) The tender should be clearly marked and must be submitted to 24 Hertzog Street, Hartswater.
- b) Faxed and late tenders will not be accepted.

15. Expenses Incurred in Preparation of Tender

The Municipality shall not be liable for any expenses incurred in the preparation and submission of the tender.

16. Contact with Municipality after Tender Closure Date

Bidders shall not contact Phokwane Local Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded. If a bidder wishes to bring additional information to the attention of Phokwane Local Municipality, it should do so in writing. Any effort by the firm to influence Phokwane Local Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

17. Opening, Recording and Publications of Tenders Received

- a) Tenders will be opened on the closing date immediately after the closing time specified in the tender documents. If requested by any bidder present, the names of the bidders, and if practical, the total amount of each bid and of any alternative bids will be read out aloud.
- b) Details of tenders received in time will be recorded in a register which is open to public inspection.
- c) Faxed and late tenders will not be accepted.

18. Evaluation of Tenders

Tenders will be evaluated in terms of their responsiveness to the tender specifications and requirements as well as such additional criteria as set out in this set of tender documents.

19. Procurement Policy

Bids will be evaluation in terms of the 80 (price) /20 (B-BBEE status) preferential point system. Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000 and its amendments as well as the Municipality's Supply Chain Management Policy.

20. Contract

The Municipality, at its discretion, may request the signing of an additional Service Level Agreement which, together with the signed tender document, will constitute the full agreement between the Municipality and the successful bidder.

21. Subcontracting

- a) The service provider shall not subcontract the whole of the Contract.
- b) Except where otherwise provided by the service provider, the service provider shall not subcontract any part of the Contract without the prior written consent of the Municipality, which consent shall not be unreasonably withheld.
- c) The contractual relationship between the service provider and any subcontractors selected by the service provider in consultation with the Municipality in accordance with the requirements of and a procedure contained within the Scope of Work, shall be the same as if the service provider had appointed the subcontractor in terms of paragraph (b) above.
- d) Any consent granted in accordance with paragraph (b) or appointment of a subcontractor in accordance with paragraph (c) shall not imply a contract between the Municipality and the subcontractor, or a responsibility or liability on the part of the Municipality to the subcontractor and shall not relieve the service provider from any liability or obligation under the Contract and he shall be liable for the acts, defaults and neglects of any subcontractor, his agents or employees as fully as if they were the acts, defaults or neglects of the service provider, his agents or employees.

22. Language of Service Provider

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

23. Extension of Contract

The contract with the successful bidder may be extended on the basis of performance with a period not exceeding 15% of the original contract.

24. Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

25. Past Practices

- a) The bid of any bidder may be rejected if that bidder or any of its directors have abused the municipality's supply chain management system or committed any improper conduct in relation to such system.
- b) The bid of any bidder may be rejected if it is or has been found that that bidder or any of its directors influenced or tried to influence any official or councilor with this or any past tender.
- c) The bid of any bidder may be rejected if it is or has been found that that bidder or any of its directors offered, promised or granted any official or any of his/her close family members, partners or associates any reward, gift, favor, hospitality or any other benefit in any improper way, with this or any past tender.

26. Validity of BEE certificates:

- a) **If the certificate was issued by a verification agency the following must be on the face of the certificate:**
SANAS logo, unique BVA number, must be an original certificate or certified copy of the original, the name and physical location of the bidder, the registration number and, where applicable, the VAT number of the bidder, the date of issue and date of expiry of the certificate, the certificate number for identification and reference, the scorecard that was used (for example EME, QSE or Generic), the name and / or logo of the Verification Agency, the certificate must be signed by the authorized person from the Verification Agency and the B-BBEE Status Level of Contribution obtained by the bidder.
- b) **If the certificate was issued by registered auditors approved by IRBA**
Clearly identify the B-BBEE approved registered auditor by the auditor's individual registration number with IRBA and the auditor's logo, clearly record an approved B-BBEE Verification Certificate identification reference in the format required by the SASAE, reflect relevant information regarding the identity and location of the measured entity, identify the Codes of Good Practice or relevant Sector Codes applied in the determination of the scores, record the weighting points (scores) attained by the measured entity for each scorecard element, where applicable, and the measured entity's overall B-BBEE Status Level of Contribution, reflect that the B-BBEE Verification Certificate and accompanying assurance report issued to the measured entity is valid for 12 months from the date of issuance and reflect both the issuance and expiry date, and the B-BBEE Status Level of Contribution obtained by the bidder and must be an certified copy of the original.

FAILURE TO COMPLY WITH THE ABOVEMENTIONED WILL RESULT IN NO PREFERENCE POINTS BEING AWARDED

27. Letter of Good Standing from the Commissioner of Compensation

- a) A valid Letter of Good Standing from the Compensation Commissioner or a copy thereof, must accompany the bid documents unless the bidder is registered on the Central Supplier Database and they have a valid Letter of Good Standing from the Compensation Commissioner or a copy thereof for the bidder on record. The onus is on the bidder to ensure that the Municipality has a valid Letter of Good Standing from the Compensation Commissioner or a copy thereof on record.
- b) In the case of a Consortium/Joint Venture every member must submit a separate valid Letter of Good Standing from the Compensation Commissioner or a copy thereof with the bid documents unless the member is registered on the Central Supplier Database and they have a valid Letter of Good Standing from the Compensation Commissioner or a copy thereof on record for all members of the Consortium/Joint Venture.
- c) If a bid is not supported by a valid Letter of Good Standing from the Compensation Commissioner or a copy thereof, either as an attachment to the bid documents or on record in the case of suppliers registered on the Central Supplier Database, the Municipality reserves the right to obtain such document after the closing date. If no such document can be obtained within a period as specified by the Municipality, the bid will be disqualified.
- d) If a bid is accompanied by proof of application for valid Letter of Good Standing from the Compensation Commissioner, the original or copy thereof must be submitted on/or before the final date of award.
- e) Should a bidder's Letter of Good Standing from the Compensation Commissioner expires during the contract period, a valid certificate must be submitted within an agreed upon time.
- f) The right is reserved to not award a tender if a valid Letter of Good Standing from the Compensation Commissioner or a certified copy thereof is not submitted within the requested time.

28. Authorized Signatory

- a) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorized to sign it for and on behalf of the bidder.

29. Negotiations

Should the tender prices be higher than the available funds of the client, the client reserves the right to negotiate with the successful bidder to limit the work in accordance with the tender specifications in order not to exceed the available budget.

30. SABS Approved

Product must be SABS approved.

31. In the case of a Trust, Consortium or Joint venture the following will apply:

- i) The Trust, Consortium or Joint venture agreement must be submitted as part of the bid documents;
- ii) No amendments to Trust, Consortium or Joint venture agreement may be made without the prior approval of the Municipality; if not accepted by the Municipality and the Trust, Consortium or Joint venture continue without approval the Trust, Consortium or Joint venture contract can be cancelled as if poor performance had taken place;
- iii) The Trust, Consortium or Joint venture will only qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits, together with the submission of the bid, their B-BBEE status level certificate issued in the name of the Trust, Consortium or Joint venture.
- iv) All members of the Trust, Consortium or Joint venture must submit, with the bid documents:
 - a) A valid tax clearance certificate or SARS tax pin, individually;
 - b) an agreement that clearly provides clarity of Profit and liability sharing; and
 - c) a resolution taken by the board of directors of the Consortium or Joint venture and other information that agrees with the Trust, Consortium or Joint venture agreement.
- v) For the evaluation of functionality regarding a Consortium or Joint venture refer to the functionality section.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 "GCC" means the General Conditions of Contract.
 - 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
 - 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.

	<p>1.17 “Local content” means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.</p> <p>1.18 “Manufacture” means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.</p> <p>1.19 “Order” means an official written order issued for the supply of goods or works or the rendering of a service.</p> <p>1.20 “Project site,” where applicable, means the place indicated in bidding documents.</p> <p>1.21 “Purchaser” means the organization purchasing the goods.</p> <p>1.22 “Republic” means the Republic of South Africa.</p> <p>1.23 “SCC” means the Special Conditions of Contract.</p> <p>1.24 “Services” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.</p> <p>1.25 “Written” or “in writing” means hand-written in ink or any form of electronic or mechanical writing.</p>
2. Application	<p>2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.</p> <p>2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.</p> <p>2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.</p>
3. General	<p>3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.</p> <p>3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za</p>
4. Standards	<p>4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.</p>
5. Use of contract documents and information; inspection	<p>5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.</p> <p>5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.</p> <p>5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.</p> <p>5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.</p>

Warranty	<p>15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.</p> <p>15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.</p>

1. DEFINITIONS	
Unless explicitly provided in this guideline, the definitions given in SATS 1286:2011 apply.	
2. GENERAL	
2.1 Introduction	<p>This guideline provides tenderers with a detailed description of how to calculate local content of products (goods, services and works) by components/material/services and enables them to keep an updated record for verification requirements as per the SATS 1286:2011 Annexure A and B.</p> <p>The guideline consists of two parts, namely:</p> <ul style="list-style-type: none"> • a written guideline; and • three declarations that must be completed: <ul style="list-style-type: none"> – Declaration C: “Local Content Declaration – Summary Schedule” (see Annexure C); – Declaration D: “Imported Content Declaration – Supporting Schedule to Annex C” (see Annexure D); and – Declaration E: “Local Content Declaration – Supporting Schedule to Annex C” (see Annexure E). <p>The guidelines and declarations should be used by tenderers when preparing a tender. A tenderer must complete Declarations D and E, and consolidate the information on Declaration C.</p> <p>Annexure C must be submitted with the tender by the closing date and time as determined by the Tender Authority. The Tender Authority reserves the right to request that Declarations D and E also be submitted.</p> <p>If the tender is successful, the tenderer must continuously update Declarations C, D and E with actual values for the duration of the contract.</p> <p>NOTE: Annexure A is a note to the purchaser in SATS 1286:2011; and Annexure B is the Local Content Declaration IN SATS 1286:2011.</p>
2.2 What is local content	According to SATS 1286:2011, the local content of a product is the tender price less the value of imported content, expressed as a percentage. It is, therefore, necessary to first compute the imported value of a product to determine the local content of a product.
2.3 Categories: Imported and Local Content	<p>The tenderer must differentiate between imported content and local content.</p> <p>Imported content of a product by components/material/services is separated into two categories, namely:</p> <ul style="list-style-type: none"> • products imported directly by the tenderer; and • products imported by a third party and supplied to the tenderer.
2.3.1. Imported Content	<p>Identify the imported content, if any, by value for products by component/material/services. C13. Imported value

Provide the ZAR value of the items' imported content.

C14. Local value

Provide the local value of the item by deducting the Imported value (C13) from the net tender value (C12).

C15. Local content percentage (per item)

Provide the local content percentage of the item(s) by dividing the local value (C14) by the net tender value (C12) as per the local content formula in SATS 1286.

Tender Summary

C16. Tender quantity

Provide the tender quantity for each item number as per the tender specification.

C17. Total tender value

Provide the total tender value by multiplying the tender quantity (C16) by the tender price (C10).

C18. Total exempted imported content

Provide the total exempted imported content by multiplying the tender quantity (C16) by the exempted imported content (C11). These values must correspond with the values of column D18 on Annexure D.

C19. Total imported content

Provide the total imported content of each item by multiplying the tender quantity (C16) by the imported value (C13).

C20. Total tender value

Total tender value is the sum of the values in column C17.

C21. Total exempted imported content

Total exempted imported content is the sum of the values in column C18. This value must correspond with the value of D19 on Annexure D.

C22. Total tender value net of exempted imported content

The total tender value net of exempt imported content is the total tender value (C20) less the total exempted imported content (C21).

C23. Total imported content

	<p>Total imported content is the sum of the values in column C19. This value must correspond with the value of D53 on Annexure D.</p> <p>C24. Total local content Total local content is the total tender value net of exempted imported content (C22) less the total imported content (C23).
