Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed in an envelope and marked: "BID NO.: AN APPOINTMENT OF A SERVICE PROVIDER TO SUPPLY AND DELIVER ELECTRICAL MATERIAL and must be deposited in the tender box situated at the reception: Civic Centre, 2 Kingfisher Road, Mandeni no later than 12H00, on Wednesday, 15th October 2025 at which time bids will be opened in public. Closing time will only be determined by the Municipal watch displayed on the Municipal wall at the reception. The name and address of the Bidder must be clearly written on the sealed envelope containing the Bid Document. Late submission, e-mail or fax bids will under no circumstances be considered. Only bidders registered on Central Supply Database (CSD) will be considered.

The Mandeni Municipality subscribes to the preferential procurement policy framework Act, Act No. 5 of 2000 and its associated Regulations of 2022. Canvassing in any form of gift to Council is strictly prohibited and will lead to the disqualification of the bid.
