TERMS OF REFERENCE

1. Background

uMngeni-uThukela Water intends to source the service from a service provider who will be able to cut trees around the boundary fence line at Mpofana WWW, some of these trees have fallen down due to ageing and caused serious damages of the existing concrete palisade fence hence and there are more trees which will eventually fall and will destroy the remaining fence.

Trees are at least 0.8m in stem and at least 15m high.

2. Description of goods/ services required

Some of these trees have fallen down due to ageing and caused serious damages of the existing concrete palisade fence hence and there are more trees which will eventually fall and will destroy the remaining fence. Trees are at least 0.8m in stem and at least 15m high. The service provider will be required to cut down all 26 trees to at least 100mm above the natural ground level. This must be done carefully in such a manner that the existing fence is not damaged further. Cut down the tree into small logs and cart away from site. Once the tree is being cut to at least 100mm above natural ground lever then apply chemical product that will prevent the tree from growing again.

3. Delivery

The works will be at Mpofana WWW.

4. Contract term

The Contract will be for duration of three weeks.
