The Big 5 Hlabisa Municipality, in the implementation of its adopted integrated development plan: Project Implementation hereby invites bids for the Construction of Mpembeni Electrification. Tenderers must be registered and have CIDB contractor grading designation of 4EP OR HIGHER and appropriate experience in MV/LV electrical construction for the CONSTRUCTION OF MPEMBENI ELECTRIFICATION. Only local produced or locally manufactured electrical cables, residential electricity meters, transformers and shunt reactors from raw material or input will be considered. Designated steel power pylons, monopole pylons, steel substation structures, powerline hardware, steel lattice towers & masts and street lighting steel poles for 100% local content.

All prices should be inclusive of Value added Tax (VAT). Successful bidders will be required to be registered with the municipal database prior commencement of project. Bids shall remain valid for a period of 90 days from the closing date.

All above bids will be evaluated and adjudicated according to the following criteria:

Big 5 Hlabisa Local Municipality subscribes to the Preferential Procurement Policy Framework Act,2000 (Act No.5 of 2000.The 80/20 preference point system shall be applicable during the evaluation and adjudication of bids. The amended PPPFA Regulation will be used:

Functionality where tenderers must score the minimum of 60% (Experience – 40, Key personnel – 45 and Methodology
 - 15) as detailed in the tender document to qualify for further evaluation.

Second stage –Preferential point system (80/20) 80 for price and 20 for BBBEE Contribution. Only bidders who pass
the first stage with a minimum of 60% will be evaluated further in the second stage.
