C3.2.1 Overview of the Works

C3.2.1.1 SPECIFICATIONS

Specifications	Comply Yes/No	Page to reference
1. An area of 1400 m ² is to be paved with 30MPa, 80mm interlocking concrete paving, with a natural colour.		
2. Excavate the area to a depth of 300mm.		
3. Complete the 300mm base layer with G5 material and compact. The total G5 material plus spoils (10%) amounts to 462 m ³ .		
4. A 20mm sand layer is to be added on top of the base layer.		
5. Paving area is completed with 165m of E1 edge kerbs around the paved area.		

All construction work must be according to the SABS 1200 standard.

GENERAL CONDITIONS:

1. Should the bidder not provide the above-mentioned (as requested in point number 1) information the quotation will be treated as non-responsive.
2. All materials must be applied strictly in accordance with the relevant technical specifications and application manual of the product.
3. The contractor must remove all rubbish from the site.
4. The contractor must comply with all safety and health requirements in accordance with Act 85 of 1993.
5. The successful contractor must also supply his own temporary storage room/container for keeping and locking up tools, building materials and accessories during such time it takes to complete the project, if needed.
6. The quotation must include all related expenses, i.e. all new material, transport of material, labour and the removing of all refuse.

7. The completion date will be negotiated with the successful bidder.
8. A written guarantee for a period of 1 years must be submitted with the quotation. Should any defects occur due to poor workmanship under this quotation the contractor must repair the defects at his or her own cost to the satisfaction of the Municipality. The 1-year period commence from the date of the invoice.

Failure to provide the information as stated above, may result in your tender being declared non-responsive.
