<p>The National Research Foundation (NRF) seeks to appoint a suitably qualified service provider to supply and deliver personal protective equipment (PPE) and workwear clothing for four (4) Estate Management staff members. This procurement is necessitated by the nature of the daily operational duties performed by the Estate Management team, which include climbing ladders, working on uneven and grassy terrain, operating in dusty environments, and performing tasks on wet and slippery surfaces. These conditions present inherent occupational health and safety risks that require appropriate protective and durable workwear.</p> <p>The provision of quality PPE and workwear is essential to ensure compliance with occupational health and safety legislation and internal safety standards, to minimise the risk of workplace injuries, and to provide a safe and conducive working environment. In addition, suitable workwear will improve staff comfort, efficiency, and productivity, while supporting consistent service delivery and professional presentation.</p>
