3. AMMENDMENTS TO THE TENDER DOCUMENT

- 3.1 The question of an abnormally high aviation public liability insurance amount of R100 000 000.00 that was outlined on Appendix A – Insurances was raised by one bidder during the compulsory briefing session that was held on 09 June 2025. Following the consultation with the Insurance Specialist from Treasury Management on 12 June 2025, the aviation liability amount is amended as shown on table below.

4. **ACSA RESPONSES TO BIDDER'S CLARIFICATION QUESTIONS**

During the briefing session held on 09 June 2025, bidders were afforded the opportunity to ask clarification question related to the tender documents, i.e. Bid and NEC3 Contract documents and the responses as provided by ACSA are listed on table below:

No.	Bidder's Clarification Question	ACSA's Response
1	One bidder wanted to know why the accreditation to Black Contract Cleaners Association (BCCA) is not included as a mandatory requirement and whether ACSA can consider including it so that some are not unfairly disqualified for not belonging to National Contract Cleaning Association (NCCA).	A decision has been made not to include BECCA as an additional accreditation mandatory requirement. The NCCA is more detailed and requires registration, adherence to industry standards, and compliance with relevant legislation whereas, the BECCA typically involves fulfilling certain requirements based on ownership and employment.
2	A bidder asked whether the scope of work will involve the deep OR standard cleaning of escalators and travelators.	Cleaning of escalators and travelators is to undertaken using specialized and accredited machinery in line with the manufacturer.
3	A bidder wanted to know how many resources will be required.	See page 12 of the bid document and page 26 of the NEC3 TSC document.
4	A bidder wanted to know if they can be provided with the contact numbers of the manufacturers of ACSA's O.R. Tambo International Airport escalators and travelators for their advice in terms of the chemicals and machinery suitable for use in cleaning their equipment.	The POPI Act does not allow ACSA to share another service providers contact details.
5	One bidder wanted to know if they can be given an opportunity to visit the site on Friday 13 June 2025 to view one or two escalators and travelators.	ACSA do not foresee any issues with this request given that the airport is a public place. The bidder is free to visit the airport and view the escalators and travelators.
