1.5 LATE BIDS

- 1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bidders are therefore strongly advised to ensure that bids be sent allowing enough time for any unforeseen events that may delay the delivery of the bid.

1.6 NEGOTIATION

- 1.6.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.

1.7 REASONS FOR REJECTION

- 1.7.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.7.2 SASSETA shall disregard the bid of any bidder if that bidder, or any of its directors:
 - 1.7.2.1 have abused the Supply Chain Management systems of SASSETA.
 - 1.7.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
 - 1.7.2.3 have failed to perform on any contract and the proof exists.
- 1.7.3 Such actions shall be communicated to the National Treasury.

2. TERMS OF REFERENCE

2.1. INTRODUCTION AND BACKGROUND

- 2.1.1. SASSETA is one of the twenty-one (21) Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training (DHET).
- 2.1.2. The organisation is continuously enhancing its ICT infrastructure to support modern collaboration, effective communication, and improved service delivery. Current meeting spaces rely on mixed and/or outdated technologies that do not fully support hybrid meetings, remote collaboration, or centrally managed communication displays.
- 2.1.3. To address these challenges, SASSETA ICT seeks to implement:
- a) Microsoft Teams Rooms: enabled boardrooms for standardised hybrid meeting experiences.
 - b) Samsung commercial-grade displays for high-quality presentation and visual clarity.
 - c) A centralised digital signage Content Management System (CMS) for managing communication screens across offices.
- 2.1.4. This initiative supports the organisation's digital transformation objectives by modernising meeting environments, improving internal communication channels, and aligning industry standards for collaboration technologies.
- 2.1.5. The solution is intended to improve internal communication, enhance meeting efficiency, standardise AV technologies across SASSETA offices, and ensure sustainability through ongoing support.

2.2. PURPOSE

- 2.2.1. SASSETA seeks to appoint a qualified service provider to supply, install, configure, commission, and support a complete Audio-Visual (AV) and digital signage solution with support and maintenance from the date of appointment until 31 March 2030.

2.3. SCOPE OF WORK & REQUIRED DELIVERABLES

- 2.3.1. The service provider will be required to deliver:
- 2.3.1.1. turnkey solution, covering design, supply, installation, configuration, testing, commissioning, documentation, training, and support.
 - 2.3.1.2. Logitech devices: Fully equipped and operational Microsoft Teams Rooms across SASSETA Offices
 - 2.3.1.3. Commercial-grade Samsung displays
 - 2.3.1.4. Logitech devices: Room Scheduling Panels (calendar-integrated)
 - 2.3.1.5. Logitech devices: In-room Teams Controllers
 - 2.3.1.6. Centralised CMS with active digital signage screens

2.3.1.7. Cabling, brackets, and accessories

2.3.2. All AV devices to provide minimum features listed in annexure B (Artificial Intelligence (AI) framing, echo cancellation, beamforming audio or ceiling array support, 4K display with 24/7 commercial rating, Open Pluggable Specification (OPS) slot or industrial media player support, remote management, and warranty).

2.4. PENALTY FOR NON-PERFORMANCE

2.4.1. SASSETA reserves the right to enforce penalties, withhold payment, or take other remedial action should the appointed service provider fail to meet the agreed service levels, timelines, or deliverables as will be captured in the Service Level Agreement (SLA).

2.4.2. Final project timelines will be agreed upon with the appointed service provider and incorporated into the SLA. Failure to meet these agreed timelines may result in penalties as outlined in the SLA.

2.5. MANDATORY REQUIREMENTS

2.5.1. The bidding company should comply with the following mandatory requirement

2.5.1.1. submit valid Proof of OEM Authorised Partner/Reseller Status (for logitech, Microsoft teams rooms and Samsung commercial displays/magicINFO). **Failure to submit a valid Proof of OEM Authorised Partner/Reseller Status will lead to automatic disqualification**

2.5.1.2. submit the following certifications for the proposed team members:

- Audiovisual and Integrated Experience Association Certified Technology Specialist (AVIXA CTS-I (Installation)) for one (1) Senior Technician/Installer
- Technical Project Manager: AVIXA CTS (Certified Technology Specialist)
- Senior Solution Architect AVIXA CTS-D (Design)

Failure to submit either one or all the above-mentioned certificates will lead to automatic disqualification

2.6. SKILLS AND EXPERIENCE OF THE BIDDING COMPANY, THE PROJECT TEAM LEADER, AND THE TEAM MEMBERS PROPOSED FOR THE ASSIGNMENT

2.6.1. The bidding company to:

2.6.1.1. Submit a detailed implementation plan as part of their proposal including deployment, configuration, and administration setup for each platform with key activities, expected timelines, and responsible personnel, dependencies, risk mitigation approach and expected deliverables for each phase and post-implementation support and escalation process.

- 2.6.1.2. have successfully implemented the proposed solution(s) with support and maintenance. A minimum of three (3) signed reference letters confirming audio-visual solution and a minimum of three (3) signed reference letters confirming digital signage solution to be submitted.
- 2.6.1.3. The proposed Project Team to collectively demonstrate verifiable experience in the successful design, implementation, and maintenance of audio-visual and digital signage solutions:
- a) A comprehensive CV of a Technical Project Manager to demonstrate a minimum of three (3) assignments in managing successful design, implementation, and maintenance of audio-visual and digital signage solutions projects.
 - b) A comprehensive CV of a Senior Solution Architect demonstrating a minimum of three (3) assignments in designing and integrating audio-visual and digital signage solutions.
 - c) Comprehensive CVs of three (3) Senior Technicians/Installers demonstrating to have collectively installed, configured, supported, and maintained six (6) integrated audio-visual and digital signage solutions to be submitted.

2.7. TIMEFRAMES FOR DELIVERY OF THE WORK

- 2.7.1. This contract shall commence from the date of appointment and remain valid until 31 March 2030.
- 2.7.2. The service provider will be required to deliver hardware and related components within twenty-one (21) working days from the date of the order.

2.8. PRICING

- 2.8.1. The service providers are requested to provide an all-inclusive cost of this project assignment on SBD 3.3.
- 2.8.2. Where the contract requires the successful bidder to travel to a venue different from SASSETA, the following travel and disbursement processes will be undertaken:
- 2.8.2.1. Claim travel mileage costs applicable to this contract as per the Department of Transport rates
 - 2.8.2.2. Book only economy-class flights
 - 2.8.2.3. Book Group A hire cars, otherwise, Group B are to be used for service Providers outside of Gauteng.
 - 2.8.2.4. Utilise cost-effective mode of transport such as Uber/Taxify/Gautrain or shuttle services when travelling to and from the airport
 - 2.8.2.5. Book only Bed and Breakfast, Hotels, or other equivalent accommodations up to a Rand value of R1 400/ three (3) Star per night per person (including dinner, breakfast and parking).

2.8.2.6. Submit all applicable invoices/receipts for the travel undertaken and also a google map of the trip where travel by private car was undertaken for payment.

2.8.2.7. All travel to be approved by SASSETA before being undertaken.

2.9. ACCOUNTABILITY AND REPORTING

2.9.1. The service provider will report directly to the ICT Manager for the duration of the contract.

2.10. CONDITIONS OF CONTRACT (GCC) (ANNEXURE A)

2.10.1. Bidders are requested to initial each page of the General Conditions of Contract (GCC) (Annexure A) and submit their response to this Request for Quotations. The GCC will form part of the contract with the successful Bidder.

2.11. INTELLECTUAL PROPERTY

2.11.1. The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analysed, will be confidential information for utilisation by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Service Level Agreement.

2.12. PROTECTION OF PERSONAL INFORMATION ACT

2.12.1. All Service Providers are to take note of the implications of POPIA act and any other data privacy Act applicable that SASSETA complies to. In compliance to the act, please be advised that the following are applicable to the treatment of vendor information:

2.12.1.1. All requested bid information will be solemnly utilized for the purpose of the bid evaluation processes. The vendor hereby consents the information provided as part of this bid will be utilized for supply chain processes of SASSETA and may be subject to multiple processing to enable the evaluation of this bid.

2.12.1.2. The vendor consents that the information collected will be retained for the duration of the evaluation and archived for records management purposes. The information will be disposed as per the SASSETA records management policies as prescribed by the national archives act. Furthermore, the information owner acknowledges that the information provided will be scanned into digital records which are retained on the SASSETA backup servers and that are replicated to backup media. - 2.12.1.3. SASSETA confirms that all submitted records will be retained in their original form and will not be altered with to preserve the quality and originality of information provided.

SASSETA confirms that the Information Officer is duly responsible for vendor information provided and exercises stringent measures to ensure that information is secured and solemnly utilized for the purpose of use.
