Proposals sealed and individually clearly marked “**with the proposal number and description of choice as detailed above**” must be placed in the Municipal tender box, **26 Church Street, OUTDSHOORN** no later than **12h00 on MONDAY, 09 OCTOBER 2023** and will be opened in public immediately thereafter at the **Supply Chain Management Office, 26 Church Street, OUTDSHOORN** or any alternative place in Oudtshoorn Municipal Offices.

Bidders must have a **CIDB GRADING OF 4EP OR HIGHER.**

Functionality will be applicable and bidders scoring less than 70 out of 100 will be deemed non-responsive and will not be evaluated any further.

A set of fully completed proposal documents must be submitted on the original documents and remain valid for a maximum of **120 days** after the closing date of the tender. A set of proposal documents can be obtained at a non-refundable cost of **R361.00 including VAT** for hard copies directly printed by the Municipality and **free of charge when provided on pdf via e-mail**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the proposal document at the SCM Offices.

Proposal documents will be available as from **MONDAY, 11 SEPTEMBER 2023**. A compulsory clarification meeting will be held on **MS TEAMS ON TUESDAY, 19 SEPTEMBER 2023 AT 10:00**.

The municipality reserves the right to withdraw any invitation for proposal and / or re-advertise or to reject any formal proposal or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this proposal may not materialize.

The above requests will be evaluated and adjudicated in terms of the **80/20** or **90/10** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022) whereby the highest acceptable tender will determine the preference point system to be used, and Oudtshoorn Municipality’s Supply Chain Management Policy. Further note, it is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database to be registered, registration can be done online via www.csd.gov.za
