1. INTRODUCTION

This bid provides for the repairs and maintenance of municipal buildings for the duration of 36 months for Elias Motsoaledi Local Municipality. Elias Motsoaledi Local Municipality requires rates proposal for various items related to building maintenance for various buildings situated in Hlogotlou cluster, Uitspanning cluster, Motetema cluster, Rossenekal cluster and Groblersdal cluster.

2. KEY DELIVERABLES

- (a) Provision to the municipality repairs and maintenance that is efficient, reliable and cost-effective in order to ensure business continuity of the Municipality.
- (b) Provision of building inspection report information that will bring efficiency and ensure economic viability of the maintenance
- (c) Ensure that there is preventative and reactive maintenance of all buildings to ensure safe and compliance of working conditions in workplace
- (d) Provision and resolution of queries.

3. SCOPE OF WORK

PROVISION FOR THE REPAIRS AND MAINTENANCE OF MUNICIPAL BUILDINGS

- Elias Motsoaledi Local Municipality requires the services of a suitably qualified and capable service provider to provide services in relation to the provision of repairs and maintenance to all buildings of the municipality.
- The Contractors/Service Providers shall provide maintenance services for municipal buildings, equipment and associated infrastructure involving the following engineering and general disciplines:
- Annual/periodic visits: inspection of general buildings to ensure if they are still suitable for occupation
- Annual/periodic visits: testing of pumps, boreholes and other equipment's to ensure if they are still operating within specification parameters
- Removal/Replacement of Pumps and other redundant equipment
- Rehabilitation/Refurbishment of existing building structures, boreholes and equipment's etc.
- Priority emergency callouts
- Repair and maintain the buildings in accordance with the acceptable standards.(NHBRC)
- EMLM will not guarantee any quantities in respect of the buildings to be repaired and maintained in this document and requirements will be as and when the need arises.
