3. Scope of works/Technical specifications

3.1 BACKGROUND

The Office of the Chief Executive Officer plays a crucial role in ensuring that the mandate of SANEDI is executed. Efficient and effective operation of this office is critical. Most importantly, the credibility and integrity of technical documents signed-off and in some cases issued publicly by the CEO carries the most risk and reputation for the CEO, SANEDI Board and the Minister. There is therefore a need for independent technical management services in the office of the CEO.

3.2 OBJECTIVES

Note: The successful service provider will **first** need to meet the **Technical Threshold** provided in this document, and if then successful, those Services Providers will be invited to **‘pitch’** their proposal to an Evaluation Panel (online or in-person), addressing the following mandatory areas:

- Assisting the CEO in drafting technical briefing notes for the attention of the Board, DMRE and DSI on Energy matters
- Reviewing and liaising with the CEO direct reports to make sure accurate and professional quality of documents before CEO sign-off.
- Assisting the CEO to prepare for meetings with key stakeholders.
- Assisting the CEO to prepare technical articles for publication in journals and presentations to conferences/ forums.
- Management of interns linked to SANEDI projects, either internally or externally

In performing this function, the Service Provider will have access to all information about the institute and the environment it operates in. The Service Provider must have a clear understanding of the nature and character of energy research and energy sector, so that it is able to assist the CEO with specialised engineering and technical work. Knowledge of the target market, the media habits and exposure of the target market are required for this purpose.

TERMS OF REFERENCE**3.3 Scope of Work**

The Service Provider will be responsible to create and execute the following:

- (a) Review technical reports.
- (b) Write technical reports and briefing notes.
- (c) Do basic energy modelling.
- (d) Prepare presentations.
- (e) Perform basic design calculations, techno-economic analysis and technical risks assessments.
- (f) Do literature survey and reviews.
- (g) Provide engineering support services to support the Chief Executive Officer (CEO)
- (h) Develop and maintain engineering support strategies, services and controls necessary to enhance the effectiveness and efficiency of the Office of the CEO
- (i) Scanning and interpreting the international and local energy business environment to ensure that SANEDI CEO has access to engineering business best practices.
- (j) Assist the CEO in interpreting the business management environment and manage requirements to ensure alignment and to ensure compliance to business policies and directives.
- (k) Assist the CEO in driving the formulation and implementation of operational strategies to achieve the business objectives.
- (l) Assist the CEO to influence technical governance at SANEDI.
- (m) Assist the CEO in identifying and applying research support practice, suitable methodology and processes which are aligned with global standards to ensure repeatable and consistent delivery of energy research solutions.
- (n) Assist the CEO in establishing and maintaining relationship with other organisations to benchmark SANEDI practices and organisational maturity.
- (o) Assist the CEO to continually build relationships with key stakeholders at Executive and other levels, and comparable organisations.
- (p) Assist the CEO to manage SHEQ compliance across the organisation.
- (q) Assist the CEO in developing and establishing Technical Governance Framework for SANEDI
- (r) Assist the CEO in managing the interns and ensuring they follow a set programme in line with their professional registration bodies.

3.3.1 Co-ordination

The Service Provider will be responsible for coordination between all key stakeholders (internal and external), to ensure integrity of technical information and documents issued from the Office of the CEO.

3.3.2. Access to databases

The Service Provider shall help the CEO to access technical databases required to verify and validate certain technical information.

3.3.5. Project duration

Duration of the Work

The duration of the service will be for a period of 24 months, to be executed on an ‘as-and-when’ basis, i.e. when CEO makes a request. Hours spent per month will be capped at 160 hours. All other costs will be re-imbursed at cost, and these costs shall not exceed 15% of the total contract value.

4 Evaluation Criteria

Phase 1: Initial Screening Process: At this phase bidder's response are reviewed to check if bidders have responded according to SANEDI's RFP document.

Phase 2: Mandatory Requirements: It must be noted that bidders who fail to meet any of the MANDATORY REQUIREMENTS will be disqualified and not be evaluated further.

Phase 3: Technical evaluation: Bidders will be evaluated according to the below technical evaluation criteria. **The first stage will be the (functionality and must be met before being able to pass onto Presentation (Pitch) evaluation of this bid).**

Minimum Technical Threshold is **80%**.

It must be noted that if the Bidder does not meet the **80%** minimum threshold, the bidder will be disqualified and not be evaluated further.
