**Supply, Delivery and Installation of 3 x Fume Hoods to IThemba LABS Nuclear Medicine**

**Department.**

- Ducted fume hoods able to remove corrosive and gaseous vapors from the work area by drawing air up from the fume hood through the duct and push the hood air out the exhaust stack/atmosphere using exhaust fans.
- The fume hoods must comply with the safety requirements of the European Standard EN 14175 or the American Standard ASHRAE 110-2016
- Electrical Outlets with Splash Proof Cover
- Light and Fan Switch
- Support stand
- The shall be alarms for front face velocity monitoring and sash alarms.
- The sash shall have the capability to completely close off the hood face.
- 4/6 ft Fume Hood
- Separate ducting and extraction to be included and quoted for each fume hood. See ducting requirements below.

**Ducting requirements**

- Fume Hood 1 – 4ft
- Ducting exhausts to atmosphere, refurbish existing PVC ducting and provide new fan.  
Manual damper required
- Fume Hood 2 – 4 ft
- Ducting to exhaust to atmosphere. New PVC super duct/ducting/fan to be quoted and installed. Manual damper required

- Fume Hood 3 – 6ft
- Ducting to HVAC, no requirement for new ducting. Couple new Fume Hood to existing ducting

**Material of Construction:**

- Exterior of the hood shall be constructed of electrogalvanized steel with oven-baked epoxy-polyester hybrid Isocide powder coating.
- Internal liner shall be constructed of durable and corrosion resistant resin.
- The average extraction face velocity must be 0.3 - 0,6 m/s
- Worktop must be able to handle a 20 kg load of lead shielding bricks
- The hood shall have perforated, corrosion-resistant baffles to capture fumes quickly and ensure smooth laminar airflow near the working area of the fume hood.
- The chain-and-sprocket system, vertical sliding sash shall be constructed of tempered safety glass and shall be surrounded with a molded corrosion resistant frame.
- Exhaust collar shall be tapered and molded of corrosion resistant material
- Durable support stand to be constructed of electrogalvanized steel coated for maximum corrosion resistance
- Electricity supply: single-phase 220-240 V, 50/60 Hz
- Power recovery in the event that there is a power outage, system should start up automatically once the power is restored.
- Provide training and training certificates to users covering operation and cleaning

**Documentation Requirements**

  - Recommended spare parts list
  - Perform IQ/OQ Documentation and provide documentation

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
