1. BACKGROUND OF THE COUNCIL FOR MEDICAL SCHEMES

The Council for Medical Schemes is a statutory body established by the Medical Schemes Act (131 of 1998) to provide regulatory supervision of private health financing through medical schemes; and functions as a Schedule 3A Public Entity.

VISION

To be an agile and transformative Regulator in order to promote affordable and accessible healthcare cover towards universal health coverage.

MISSION

The CMS regulates the medical schemes industry in a fair and transparent manner and achieves this by:

- Protecting the public and informing them about their rights, obligations and other matters in respect of medical schemes.
- Ensuring that **complaints raised by members** of the public are handled appropriately and speedily.
- Ensuring that all entities conducting the business of medical schemes, and other regulated entities, comply with the Medical Schemes Act.
- Ensuring the improved management and **governance** of medical schemes.
- Advising the Minister of Health of appropriate regulatory and policy interventions that will assist in attaining national health policy objectives.
- Ensuring collaboration with other stakeholders in executing our regulatory mandate.

2. SCOPE OF WORK

2.1. The Council for Medical Schemes requires the services of a service provider to facilitate training for Employment Equity (EE) Forum and Training Committee as per the following specifications:

2.1.1. Services required:

2.1.1.1. The CMS has established a new EE Forum and Training Committee and wishes to empower them to effectively discharge their respective regulatory duties.

2.1.1.1.1. Training to include:

- The purpose of the Act (implementation in line with new amendments) the forum will be shown the challenges
 of meeting this purpose in practice and the impact thereof on the HR environment as required by Chapter 2 of
 the EE Act
- Consultation: the importance of the Forum, what to consult on, how to consult and how to leverage the consultation process as required by **section 16 and 17** of the EE Act.
- Role clarification: The role of the forum in employment equity management, HR Department, Line Management
- Communication: what to communicate on, how to communicate and who to target, and the involvement of Forum as required by section 25 of the EE Act

- Analysis: how to conduct the analysis of employment of policies, procedures, practices, the work environment, and workforce profiles- the role of the forum will be clarified as required by section 19 of the EE Act
- Developing affirmative action measures and setting numerical goals and targets. Under this aspect the Forum will be made to understand the requirements of:
 - the EE Act regarding targets
 - ➤ the Role of the Forum in the development, implementation, monitoring of the EE plan as required by section 20 and 23 of the EE Act
- 2.1.1.1.2. The newly constituted Training Committee would be capacitated on the role, responsibility, and duties of the training committee. The following topics must be covered by the Facilitator amongst others:
 - Skills Development Act and its purpose
 - How to achieve this Purpose
 - Regulatory requirements of the Act
 - Skills Development levies
 - SETA (Sector for Education Training & Authority) role
 - Role of the employer vs the role of SETA
 - Workplace Skills Plan (WSP) and Annual Training Report:
 - Pivotal training & non-pivotal training
 - Skills Program/Learnerships/Internships/Apprenticeship
 - Various grants offered by the SETA
 - Functions & Responsibility of the Training Committee
 - The role of the Skills Development Facilitator

2. EVALUATION CRITERIA

3.1. Table 1 - Evaluation Process and Criteria

Stage	Details
Phase 1	Mandatory evaluation criteria: The purpose of this criteria is to evaluate the bidders on their eligibility and previous experience to provide the service. Bidders who fail this Phase will not proceed to Phase 2 .

3.1.3.1. 3.2. General Conditions to specific goals

- 3.2.1. Only a bidder who has completed and signed the declaration (SBD 6.1.) part of the RFQ documentation will be considered for preference points.
- 3.2.2. CMS may, before a RFQ is adjudicated or at any time, require a bidder to substantiate claims it has made with regard to preference.

3.3. Submission of mandatory documents

- 3.3.1. Bidders must submit the following documents for verification of specific goals points:

4. INSTRUCTIONS TO BIDDERS

4.1. Terms and Conditions

The Council for Medical Schemes reserves the right, under exceptional circumstances, to extend the closing date. All proposals and all subsequent information received from bidders will not be returned.

The adjudication process does not represent a commitment on the part of Council for Medical Schemes to proceed further with that proposal or of any other bidder.

4.2. Changes to this RFQ document

Council for Medical Schemes reserves the right to make changes on this RFQ Document. All changes will be communicated to those firms that have responded to the RFQ. No reliance shall be placed on other information or comment from any other person.

4.3. Validity Period

The validity period of the RFQ/RFP is <u>ninety (90)</u> days. Request for extension of validity period will be communicated to those service providers who responded to the RFQ/RFP.

4.4. Confidentiality

Any information relating to the submissions, through the process or otherwise shall be treated in strict confidence.

4.5. Other matters

Council for Medical Schemes reserves the right not to enter into any relationship and no correspondence pertaining to submissions will be entered into.

The Council for Medical Schemes will not accept any responsibility for costs incurred by bidders in preparing and submitting proposals.

The Council for Medical Schemes reserves the right to engage in a process to validate all claims made in the proposal.

The Council for Medical Schemes reserves the right to cancel the award if it is determined that the supplier/service provider recommended for award, has engaged in corrupt or fraudulent activities in competing for the contract in question.
