1. OVERVIEW OF NDA

- a. The National Development Agency (NDA) reports to Parliament through the Department of Social Development. The NDA is classified as a public entity under schedule 3A of the Public Finance Management Act, 1999 (Act No. 1 of 1999), and was established in November 1998 by the National Development Act, 1998 (Act No. 108 of 1998) (NDA Act) as government's response to the challenge of poverty and its causes in South Africa.
- b. The NDA derives its mandate from the National Development Agency Act, 1988 (Act No. 108 of 1998). In terms of the Act, the primary objective of the NDA is to contribute towards the eradication of poverty and its causes by granting funds to CSOs for the purposes of:
 - (i) carrying out projects or programmes aimed at meeting the development needs of poor communities; and
 - (ii) strengthening the institutional capacity of other CSOs involved in direct service provision to poor communities.
- c. The secondary objects of the NDA in terms of the Act are-
 - (i) to promote-
 - (ii) consultation, dialogue and sharing of development experience between CSOs and relevant organs of State; and
 - (iii) debate on policy development
 - (iv) to undertake research and publication aimed at providing the basis for development policy.
- d. The NDA plays a critical role in contributing towards shifting the country from the scourge of poverty towards poverty eradication. Through the Act and various policies, the NDA contributes to – but is not limited to – the advancement of economic development, social cohesion, access to basic human rights and skills development. This contribution of the NDA supports the National Development Plan (NDP) 2030 outcomes for a greater and better South Africa.
- e. The National Development Plan (NDP), the Medium-Term Strategic Framework (MTSF), Sector Plans and the United Nations Sustainable Development Goals (SDGs) guide the NDA's functions. The aim of the NDP is in line with the NDA's mandate. The NDP aims to reduce inequality and eliminate poverty by 2030.

2. PURPOSE & OBJECTIVE OF THE REQUEST FOR BIDS

The NDA seeks to identify letting agents and property owners that can assist it in identifying premises that can best suit its needs. The NDA seeks premises in:

This bid therefore invites letting agents and property owners to submit bids to the NDA.

3. SCOPE OF WORK/DELIVERABLES

The letting agent/ property owner is required to identify premises for the NDA that meet the requirements detailed below:

3.1 The premises should be:

- a) Centrally located, near public transport (2km radius from the office space).
- b) Accessible / friendly to people with disabilities (the premises must have a lift or be on the ground floor with a ramp and rail).
- c) Provide for number of Parking Bays as per Table 2.1 of this document.
- d) Ablution facilities for men, women and for people with disabilities. *Should the landlord not have readily available ablutions for people with disabilities, a written commitment to build such, in the event of a successful bid must be submitted. This will be at the costs of the landlord and not part of the TI.*
- e) Premises should allow for partitioning in accordance with NDA's office needs.
- f) Security: proposed premises must have a highly monitored/controlled digital security system for controlled access to the building, cameras at all entry points (including parking) as well as a physical guard 24/7.
- g) Provide backup power for 24 hours in case of power outages.
- h) Premises must be an A or B grade in accordance with SAPOA grading definitions

All the above information must be confirmed in the form of a letter on the service provider's letterhead and MUST be signed.

4. SPECIAL TECHNICAL CONDITIONS

4.1 Requirements for the building:

- 4.1.1 Letter from architects or Property Practitioner registered in accordance with Property Practitioners Act confirming that the building is a grade A or B per SAPOA Grading definitions.
- 4.1.2 Letter confirming that the bidder has an architectural team that will be available to engage with NDA at partitioning stage.
- 4.1.3 Letter confirming that the maintenance of the building including fire extinguishers shall be the responsibility of the landlord.
- 4.1.4 Letter confirming that window blinds will be installed on all windows. The colour for the blinds shall be in line with the NDA corporate ID.

Failure to submit the above will result to disqualification.

5. PROPERTY SELECTION PROCESS

Process to be followed for property selection will be as follows:

Phase 1

- ✓ NDA's Bid Evaluation Committee (BEC) will convene and evaluate all proposals received.
- ✓ All properties will be visited for physical inspection by NDA's BEC team.
- ✓ This team will be verifying all information submitted by service providers with regards to the proposed properties.

Phase 2

- ✓ The BEC will write final recommendations to NDA's Bid Adjudication Committee (BAC) for final adjudication and further recommendation for approval by the relevant authority.

Note: Bidders who score less than 80 points on technical evaluation will not be evaluated further.

5.2 Clarification of scoring system for Technical Evaluation

a) Centrally located, near public transport (2km radius from the office space). -- (5).

Point allocation:

- **Full points will be allocated for radius between 0 to 1km**
- **3 points for a radius between 0 to 2)**

b) Accessible / friendly to people with disabilities (the premises must have a lift or be on the ground floor with a ramp and rail) - (5)

Point allocation:

- **Full points for ground floor with a ramp and rail.**
- **Full points for a functional lift.**

c) On-site undercover or shaded Parking Bays as per the table in Table 2.1 of this document.
– (5)

Point allocation:

- **Full points for undercover bays.**
- **3 points for shaded parking bays.**

d) Ablution facilities for men, women and for people with disabilities – (5)

Point allocation:

- **Full (5) points for building with existing ablution facilities for people with disabilities.**
- **3 points to be allocated if the proposed building does not have ablution facilities for people with disabilities at time of site inspection, but property owner commits to reconfigurations to cater for these.**

e) Provide written confirmation that proposed premises will allow for partitioning in accordance with the NDA's office needs. - (5) - **(Note: Failure to give consent for partitioning will result in a score of zero)**

f) Security: proposed premises must have a monitored security system with controlled access to the building as well as a physical guard 24/7 – (10)

Point allocation:

- **3 points for physical guard.**
- **4 points for monitored security system.**
- **3 points for controlled access.**

g) Provide backup power for 24hours in case of power outages. - (15) **(Failure to provide confirmation will result in a score of zero)**

6. COMMERCIAL EVALUATION

- (a) Bids will be evaluated in accordance with the NDA's Supply Chain Management Policy and Preferential Procurement Policy, 2023, using the 80/20 preference points system as prescribed in the Preferential Procurement Policy Framework Act (PPPFA, Act 5 of 2000). The lowest acceptable bid will score 80 points for price (the lowest acceptable bid will score 80 points and bidders that quoted higher prices will score lower points for price on a pro-rata basis).
- (b) The bid proposals received will be evaluated in Four(4) phases, namely Phase1 : SCM administrative compliance, Phase 2: Compliance to Mandatory Requirements, Phase 3: Functionality and Phase 4:evaluation in accordance with the 80/20 preference point system.
- (c) Bid proposal must score a minimum of eighty (80) points out of hundred (100) points on functionality in order to qualify for advancement to the next phase of evaluation. Second phase, a bid proposal scoring less than eighty (80) out of 100 will not be considered for further evaluation and will be disqualified.
- (d) Phase Four: During this phase, bid proposals that passed the first phase will be further evaluated based on the 80/20 preference points system in accordance with the PPPFA Act, where 80 points will be attained in respect of price (the lowest acceptable bid will score 80 points and bidders that quoted higher prices will score lower points for price on a pro-rata basis), 10 points will be awarded for Enterprises owned by black people, 4 points for enterprise located in Nelspruit, 2 points for Enterprises owned by black African women, 2 points for Enterprises owned by black African youth and 2 points for Enterprises owned by black African with disability. The CSD I AM register report will be used to allocate points and the (80/20 system) will be applied in accordance with the table below:

Enterprises owned by black people	10 points % shareholding by black people will determine the points
Enterprises located in Nelspruit (Mpumalanga Province) (A certified proof of address (municipal rates/stamped letter from a councillor) must be attached to claim points. The NDA will verify the location using CSD report.	4 points Should no declaration or proof be supplied, the bidder will score zero but will not be disqualified.

• Enterprises owned by black African women.	2 points % shareholding by the targeted group will determine the points that are scored
• Enterprises owned by black African youth.	2 points % shareholding by the targeted group will determine the points that are scored
• Enterprises owned by black African with disability	2 points % shareholding by the targeted group will determine the points that are scored

(e) The highest ranked bidder will be awarded the bid. It should be noted also that the NDA reserves the right not to appoint any service provider and no service provider will be reimbursed for any costs incurred whilst participating in this bid.

7. JOINT VENTURES, CONSORTIUMS AND TRUSTS

A joint venture, consortium, trust, partnership or any form of agreement will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.

A joint venture, consortium, trust, partnership or any form of agreement will qualify for points for their B-BBEE status level as an unincorporated entity if the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

Bidders must submit concrete proof of the existence of joint ventures, consortium, trust, partnership or any form of agreement. The NDA will accept signed agreements as acceptable proof of the existence of a joint venture and/or consortium arrangement.

When bidding through a Joint Venture, the Joint Ventures must submit a Consolidated B-BBEE certificate if it is not an incorporated entity when responding to tenders. This means that the bidder will have to obtain a new B-BBEE certificate for the Joint Venture, which consolidates each participant's B-BBEE status level.

8. CLIENT BASE

The NDA reserves the right to contact references "**conduct due diligence**" during the evaluation and adjudication process to obtain information.

10. PRICING

- (a) Bidders must submit a detailed cost breakdown for all applicable costs e.g. Initial setup costs, monthly costs, and any other applicable costs. All prices submitted must be inclusive of VAT.
- (b) Prices must be fixed and firm for the duration of the proposed contract period.
- (c) Bidders must ensure that the quotes submitted have no arithmetic errors as NDA will not rectify any errors and no adjustments to quotations received will be permitted.

- (d) Bidders will carry the responsibility of ensuring that the proposals submitted have been signed by a duly authorised person. Should it be established after the submission of proposals that the signatory authorising the proposal is not legally appointed by the service provider, the offer/proposal will be disqualified from the evaluation process.
- (e) All prices submitted should be typed in black ink or written in pen, proposals written in pencil will not be accepted and evaluated.
- (f) A two-envelope system will be used for the submission of proposals.

11. TENDER VALIDITY

All submitted bids must be valid for 150-days from the closing date of this bid.

12. NDA PAYMENT TERMS

Invoices will be paid 30-days from the date of submission and approval. All invoices must be sent to the following e-mail address: Invoices@nda.org.za

13. SCM ADMINISTRATIVE DOCUMENTS-COMPLIANCE

- (a) Valid Tax Clearance Certificate issued by the South African Revenue Services (SARS). Where consortium/joint ventures/sub-contractor are involved in each party to the association must submit a separate valid original Tax Clearance Certificate or SARS tax Pin or a CSD report. Alternatively, service providers must fully complete Standard Bid Document 1 (SBD 1) to give effect to the tax compliance status system.
- (b) Signed agreements for joint ventures and/or consortium arrangements.
- (c) Company registration documents (CIPC).
- (d) A letter/resolution authorising the person signing the bid documents and contracts.

Participating bidders must fully complete, sign and return ALL the attached SBD forms together with their proposals:

- SBD 1: Invitation to Bid, must be fully completed and appropriately signed
- SBD 3.1: Pricing Schedule, must be fully completed and submitted together with a detailed cost breakdown in excel
- SBD 4: Declaration of interest, must be fully completed and appropriately signed
- SBD 6.1: Preference Points Claim Form. **NB Bidders must claim specific goals by completing SBD 6.1 (Failure to claim the specific goals points will result in not allocating points). The points claimed will varied using “CSD I AM REGISTERED”.**

Failure to submit a completed SBD 3.3 in full will render the bid non-responsive. Bidders must submit a detailed itemised price breakdown together with the SBD 3.3. The total bid offer amount reflected on the SBD 3.3 must correspond with the submitted price breakdown."

NB: Bidders who fail to submit any of the above required administrative documents or fail to comply with administrative requirements will be disqualified.

14. MANDATORY REQUIREMENTS

- a) A copy of municipal issued Zoning Certificate that spell out the property's approved uses and development rules.
- b) Copy of Municipal Issued Occupancy Certificate or Use certificate that confirms that the building **meets the minimum requirements** of health, safety, and building regulations
- c) Signed written confirmation that bidder allows branding inside and outside the building (*attach written and signed confirmation*).
- d) The tenant improvement/installation allowance amount should be clearly indicated on the bid document at R900 excl. VAT/square metre (*attach written and signed confirmation*). The TI amount will only be used for partitioning, paintwork, flooring & skirtings, electrical installations, installation of a kitchenette, installation of signage amongst others. All other requirements for the office must be catered for by the landlord. (*the TI amount will not be supplemented by the NDA*).
- e) The office building must be located on the ground floor or MUST have an existing fully functional elevator/lift (if located beyond the ground floor). (*attach written and signed confirmation*).
- f) The property must have air conditioners that will cater for all staff whether in open plan or private offices. The air conditioners must also be controlled by the NDA employees for the allocated office space. (i.e. no centrally controlled air conditioner system will be accepted). (*attach a signed written confirmation*).
- g) Certificate of Occupational Health and Safety (OHS) compliance for the building issued by an accredited OHS consulting company or practitioner registered with **the South African Institute of Occupational Safety and Health (SAIOSH)**.

Failure to submit any of the documents required in this section will result in immediate disqualification from the bid process.

15. CENTRAL SUPPLIER DATABASE

The NDA will not appoint any supplier who is not registered as a prospective supplier on the central supplier database as required in terms of National Treasury Circular No. 3 of 2015/2016 and National Treasury SCM Instruction note 4 of 2016/2017.

16. CONTRACT AWARD

A binding contract will be signed after both parties have fully agreed to the scope of work and all terms and conditions. The NDA legal department will develop a draft contract that shall be used as the basis to finalise contract terms and conditions.

17. DISCLAIMER

- (a) Whilst all due care has been taken in connection with the preparation of this bid, the NDA makes no representations or warranties that the content in this bid or any information communicated to or provided to bidders during the bidding process is, or will be, accurate, current or complete. The NDA and its officers and employees will not be liable for any information communicated which is not accurate, current or complete.
- (b) If a bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by the NDA (other than minor clerical matters); the bidder must promptly notify NDA in writing of such discrepancy, ambiguity, error or inconsistency to allow the NDA to consider what corrective action is necessary (if any).
- (c) Any actual discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by the NDA will, if possible, be corrected and provided to all bidders without attribution to the bidder who provided the written notice.
- (d) No representations made by or on behalf of NDA about this bid will be binding on the NDA unless that representation is expressly incorporated into the contract ultimately entered between NDA and the successful bidder.

18. ADDITIONS AND AMENDMENTS TO THE BID

- (a) The NDA reserves the right to change any information in, or to issue an addendum to this bid before the closing date and time. The NDA its officers and employees will not be liable in connection with either the exercise of or failure to exercise this right.
- (b) Should the NDA exercise its right to change the information in terms of clause 22.1 all amendments will be communicated to all bidders.

19. CONTENT PAGE

Participating bidders are required to submit a detailed content page and page dividers clearly indicating (cross-referencing) where each of the technical requirements is placed in their bid documents exactly as outlined in **section 5** (technical evaluation criteria) of this TORs. Any additional information that the supplier would like to provide should be referenced as well on the content page.

20. PRICE NEGOTIATIONS

- (a) Where the bidder that scored the highest total points did not quote a reasonable or a market-related price, the NDA may negotiate with the bidder to offer a reasonable or market-related price, should the adjudicator agree to this;
- (b) Should the bidder scoring the highest total points not agree on a reasonable or market-related price, the NDA may cancel the bid or negotiate with the bidder that scored the second highest total points or the third highest total points, in that order.

21. SPECIAL COMMERCIAL CONDITIONS OF THIS BID

NDA reserves the right to;

- (a) To carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid.
- (b) To correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process.
- (c) To cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.
