DETAILED TECHNICAL REQUIREMENTS

3. BACKGROUND

The South African Broadcasting Corporation (SABC) is South Africa's national broadcaster. Its objectives are to provide a comprehensive range of distinctive programmes and services with the view to inform, educate, entertain, support and develop culture in all 11 official languages. Its principal activities comprise of television and radio broadcasting utilising 18 radio stations and 3 television channels.

The SABC Eastern Cape Offices, comprising Gqeberha, and East London buildings, which requires pest control and fumigation services ensuring that the company is aligned to OHS requirements and compliance. Currently the province does has a valid contract agreement to render services and will be ending 28 February 2026.

The pest Control Service will therefore assist in trying to maintain a pet-free environment for all SABC Staff, Contractors, and Visitors to the SABC buildings in the region. This will also assist with adherence to safety compliance hygiene and environmental regulation as per Agricultural and fertilizers Act 36 of 1947: OHS Act no 85 of 199 and Hazadous chemical substance Act 15 of 1973.

4. REQUIREMENTS AND SCOPE OF SERVICES

The Service Provider will be required to render comprehensive Pest Control and Fumigation Service as follows:

4.1. GQEBERHA (PORT ELIZABETH) AREARS

- Entrance, foyers, reception area, lift, stairs, passages, kitchen, and canteen
- Offices and related areas, archives, video library, preview theatres, studio control rooms, dubbing studios and audio studios
- Toilets, bathrooms, restrooms
- Stairs, TV/OB Offices, workshops, and garages
- Four maintenance workshops
- Fleet vehicle office
- Wellness Centre / Clinic and legacy Centre

4.2. EAST LONDON AREARS

- Entrances, Foyer area, reception area, stairs, passages, and kitchen
- Offices, Toilets, boardroom, equipment room and storeroom

4.3. Monthly Service and Maintenance which includes but is not limited to the following:

- Respond to callouts as and when needed
- Issuing treatment report on a monthly basis to the Logistics Manager
- maintenance and control of rodent/ mouse/rat
- Termite extermination control;
- Maggot's control;
- Fly extermination and control;
- Maintenance/Fumigation/Pest Control of potential infestation areas; as and when required
- Disinfection of viral infected facilities (fogging) e.g., covid-19
- Removal of dead birds, rodents or all vermin and cleaning and disinfecting
- Seasonal Bees management
- To supply and maintain bait boxes on strategic points
- Pest Control for cockroaches, fleas, bird-lice, flies

5. PERSONNEL REQUIREMENTS

- All personnel deployed must be trained and deployed in accordance with AGRISETA standards and SAQA.
- With every deployment for fumigation, as a minimum requirement, there must always be one (1) Licensed Operator and one (1) additional technician/assistant.

6. MATERIALS AND CHEMICALS FOR PEST CONTROL

- The Contractor shall supply all chemicals, tools, labour and all equipment necessary for the proper execution of pest control services. Chemicals used must comply with requirements of relevant government authorities and be the least toxic and harmless to humans, eco- friendly chemicals and SABS approved.
- The Contractor is to furnish names of all chemicals/insecticides to be used with the authorities' approval to SABC within 1 month from the award of the contract. Only chemicals approved by the Department of Environment are allowed for application in the premises. It is also the Contractor's responsibility that chemical usage does not defer from laws and regulations stipulated by the local government.
- All insecticides and chemicals must be used discretely. Treatment should not cause damage or be corrosive to the buildings, equipment, and electrical appliances.

- The Contractor must provide the relevant Material Safety Data Sheets (MSDS) for ALL chemicals used in and around SABC premises. It is also the Contractor's responsibility to ensure that an updated list and MSDS be provided to SABC should there be a change.

7. REGULATORY REQUIREMENTS

It is mandatory that the Pest Control Contractor is compliant with the following regulations:

- 7.1. Food Safety Act
- 7.2. Food Safety (General Food Hygiene) Regulations
- 7.3. Occupational Health & Safety Act (85 of 1993)
- 7.4. The Regulations for Hazardous Chemical Substances
- 7.5. Agricultural Pests Act
- 7.6. Fertilizers, Farm Feeds, Agricultural Remedies Act
- 7.7. Natural Environmental Management Act
- 7.8. Foodstuffs, Cosmetics and Disinfectants Act
- 7.9. All other applicable regulations

8. EQUIPMENT/S

The SABC shall not provide any equipment relating to Pest Control Services for the duration of the contract. The service provider must provide all equipment to render the service efficiently.

9. ACCESS TO THE BUILDING FOR SERVICES AND VETTING

The contractor will be granted access to the SABC buildings to render services as per the scope of work required.

SABC is a National Key Point (NKP), and it is important to note that all personnel assigned to service the site will be vetted as the NKP requirement.

10. RFQ VALIDITY PERIOD

This bid will remain valid **90 (ninety) days** from the date of bid closing.

11. COSTING

The service providers should state in writing that their quotation to the SABC and furnished information, including price, will remain valid and applicable for **90 days** from the date the vendor quotation is received by the SABC.

16.4. OBJECTIVE CRITERIA

- The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.

- No SABC former employees shall be awarded contracts with the SABC within 24 months after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 24 (twenty-four) months has expired.

- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of 24 (twenty-four) months has expired.
- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any independent contractor or independent contractor owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the Independent Contractor no longer be contracted to the SABC but become directors of other companies, the SABC shall not conduct business with those companies until the cooling-off period of 24 (twenty-four) months has expired.
- Should the Independent Contract be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

17. COMMUNICATION

- Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.
- All enquiries relating to this RFQ should be emailed three days before the closing date.

18. CONDITIONS TO BE OBSERVED WHEN TENDERING

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender.
- The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation Reserves The Right To:**
 - Not evaluate and award submissions that do not comply with this tender document.
 - Make a selection solely on the information received in the submissions.
 - Enter negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
 - Contact any bidder during the evaluation process, to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered, or permitted.
 - Award a contract to one or more bidder(s).
 - Accept any tender in part or full at its own discretion.
 - Cancel this RFQ or any part thereof at any time.
 - Should a bidder(s) be selected for further negotiations, they will be chosen based on the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

19. COST OF BIDDING

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

20. PAYMENT TERMS
