## 1. PURPOSE

The purpose of this exercise is to appoint a legible service provider for **REMOVAL AND REPLACEMENT OF EXISTING ASBESTOS ROOF SHEETS WITH NEW IBR ROOF SHEETS AT THE RECEPTION BUILDING AT TSITSIKAMMA SECTION IN GARDEN ROUTE NATIONAL PARK**

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*. SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## 3. SCOPE OF WORK

The scope of works entails the **REMOVAL AND REPLACEMENT OF EXISTING ASBESTOS ROOF SHEETS WITH NEW IBR ROOF SHEETS** at the Reception building in Tsitsikamma National Park Stormsriver mouth as per the BOQ below.

The Contractor shall supply and install IBR roof sheeting suitable for a **coastal / high-corrosion environment**, including all fixings, flashings, accessories, and installation in accordance with manufacturer specifications and SANS standards.

### Roof Sheeting Type

- Profile: **IBR (Inverted Box Rib) profile**
- Minimum thickness: **0.58 mm (recommended for coastal conditions)**
- Material: **Zincalume / Chromadek / Aluminium-Zinc coated steel** suitable for coastal applications
- Corrosion protection: Minimum **AZ200 coating** or equivalent marine-grade coating
- Finish: Factory pre-painted, UV-resistant coating system suitable for high salt exposure
- Colour: To be confirmed by SANParks

The roof sheeting must:

- Be rated for C4 to C5 corrosivity category (coastal environment)
- Have enhanced corrosion resistance suitable for exposure to salt-laden air
- Include protective coating on both top and underside surfaces
- Be supplied with a manufacturer's warranty for coastal applications (minimum 15–20 years recommended)

### Fixings and Fasteners

- All fasteners shall be stainless steel (Grade 304 or 316 recommended for coastal areas) or approved corrosion-resistant coated fasteners
- Fasteners shall include bonded sealing washers
- No dissimilar metal contact that may cause galvanic corrosion
- All flashings, ridge caps, and barge flashings to match roof material and corrosion protection standard

### **Installation**

- Installation to comply with:
  - Relevant **SANS standards**
  - Manufacturer's installation guidelines
- Minimum roof pitch: As per IBR manufacturer recommendation (typically 5° minimum unless otherwise specified) To match existing roof pitch
- Sheets to be properly aligned and securely fixed
- Overlaps to be sealed where required
- Provision for thermal expansion
- All cut edges to be treated with approved corrosion protection paint

### **Workmanship**

- Sheets to be installed straight and true
- No oil-canning, dents, scratches, or coating damage will be accepted
- All debris and metal shavings to be removed from roof after installation
- Contractor to repair any damaged coating during installation

### **Compliance**

All materials and installation shall comply with:

- Applicable **SANS standards**
- Manufacturer specifications
- Local building regulations
- Coastal environmental durability requirements

## 10. EVALUATION FORMULA FOR PRICE

## Price Formula

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

Ps = Points scored for price of the bid under consideration.

## 11. FINANCIAL PAYMENT

## 12. FINAL AWARD

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
