## **1. INTRODUCTION TO SARAO**

The South African Radio Astronomy Observatory (SARAO) embarked on a land acquisition programme during 2015 to 2017 to acquire identified portions of land to enable the construction and protection of the Square Kilometre Array (SKA) Radio Telescope. South Africa, in collaboration with Australia, jointly awarded the SKA Project in 2012.

SARAO has secured 40 portions of land as part of the SKA land acquisition programme. This equates to 135 245 hectares of land which forms part of the NRF-owned land, where 80% of the SKA Radio Telescope will be established.

In September 2019 a Management Agreement was concluded between the National Research Foundation and South African National Parks (SANParks) to appoint SANParks as the land management authority on behalf of the NRF. This appointment is in line with the management outcomes defined in the Integrated Environmental Management Plan approved by the Minister of Environmental Affairs to appoint an appropriate conservation management agency for the maintenance and management of the NRF-owned land. The land management responsibility is derived from South Africa's offer to host the SKA telescope and provide a site for the construction and operation of the radio telescope.

To enable SANParks to undertake and fulfil their functions as per the management agreement, the NRF-owned land was declared as the National Park by the Minister of Environment, Forestry and Fisheries.

## 2. SCOPE OF WORKS

SARAO invites the submission of quotations from competent services providers for the provision of the following services:

Design, Supply, Install and Certification of a New Steel Structured Shelter over the newly installed mobile office unit at Swartfontein Farm RE49, located 75km from Carnarvon in Northern Cape.

**Location: Google Earth Coordinates – latitude (S): 30° 39' 57.60" and longitude (E): 21° 31' 48.92".**

### 2.1 DELIVERABLES/ REQUIREMENTS

The scope of work for this category may include, but is not necessarily limited to, the following components as listed below:

- Design, Manufacture, Supply, Install and Certify the proposed new steel structured shelter over the existing mobile office unit (approximate unit size 11,62m long x 2,99m wide).
- The following is to apply to the new steel structured shelter:
  - Structure designed by a suitably qualified Engineer in accordance with the relevant SANS specifications,
  - Structure to be manufactured to engineers' specifications,
  - Steel posts painted,
  - Galvanised lip-channels,

- Zincaluum roof and cladding sheets painted,
- Foundations,
- SanParks colours specification (*Bidder to specify if unable to achieve this*):
  - Steel posts Outside – Plascon Micatex – Dune 4 - BBO 605
  - Roof structure (inside out) and cladding - Plascon Nuroof – Green Leaf TRP 216
- The foundations are to be designed and signed off by the respective service providers Engineer.
- Provide supervision for the installation of the structure and construction of the foundations, incl. management of the all works.
- Comply with all statutes, regulations and bylaws of local or other authorities having jurisdiction regarding the execution of the works and obtain all certificates and other documents required by such authorities. This will include final certification of structure and related works by the respective professional.
- Notify the SARAO Project Manager where compliance with any statute, regulation or by-law requires a change or variation to the works upon which such change shall be deemed to be a contract instruction.
- The Contractor shall be responsible in terms of the Occupational Health and Safety Act, 1993 (Act No 85 of 1993) and the regulations promulgated in terms of the Act or Factories, Machinery and Buildings Work Act, whichever is applicable.
- The Contractor shall be responsible for supplying and installing the necessary safety signs as determined by the Occupational Health and Safety Act, 1993 (Act No 85 of 1993) All safety signs shall comply with the requirements of the latest edition of SANS 11861 as Applicable.
