INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

Our **vision** is a future where people and nature thrive together in sustainable mega living landscapes.

Our **mission** is to conserve, expand and sustainably manage South Africa's natural and cultural assets, for the wellbeing of present and future generations, through innovation and inclusive partnerships with communities.

The National Parks under the management of SANParks are divided into 6 regions:

1. BUSINESS UNIT RESPONSIBLE FOR THE BID

SANParks' Corporate Insurance Unit is responsible for this bid. This business unit is part of the Enterprise Risk Management (ERM) Department of SANParks, responsible for maintaining and improving the ERM system of the organisation. The ERM Department reports to the Head of Governance, Risk and Compliance.

2. CONTEXT OF THIS PROCUREMENT

In the normal course of business, SANParks encounters numerous risks that pose various threats. In mitigating its risks, SANParks wishes to cost effectively transfer some of it by taking out short-term insurance cover. Therefore, SANParks requires the services of a reputable and capable service provider to provide Short-Term Insurance Brokerage Services for a period of five (5) years. The services are necessary to manage the vastly diverse and complex insurance needs of SANParks.

2.1 Contract Period

The contract duration is for a period of five (5) years.

3. SPECIFICATIONS / SCOPE OF WORK

SANParks needs to secure the services of an insurance broker with experience, expertise and capacity to act as an intermediary between the organisation and the insurance market (i.e., insurers and other risk financing institutions) and to use its leverage to secure insurance covers at the most cost-effective price.

3.1 Performance specification

The service provider will be required to provide the following general insurance actions in terms of placement, maintenance and administration of the insurance portfolio:

Placement of Insurance covers yearly

- 3.1.1 Bidder should approach all Insurers complying with the relevant statutory solvency and other requirements for placement of insurance covers
- 3.1.2 Securing short-term insurance covers for all the current classes of insurance listed under 3.2, and any other covers that might be required in future.
- 3.1.3 Internal and external discussions to set renewal and maintenance strategy;
- 3.1.4 Review existing covers;
- 3.1.5 Established uninsured risks and internal self-insurance capacity;
- 3.1.6 Review covers, limits and sums insured;
- 3.1.7 Review uninsured risks and exposure;
- 3.1.8 Re-broking and market exercise to obtain renewal terms;
- 3.1.9 Alignment of Insurance and Risk Management Philosophy;
- 3.1.10 Pre-renewal meeting to discuss excess structures and alternatives of renewal;
- 3.1.11 Renewal follow-up on alternative quotations;
- 3.1.12 Presentation of renewal terms and recommended options;
- 3.1.13 Confirmation of placement and 100% cover;
- 3.1.14 Confirmation of credit rating of insurance and re-insurance markets;
- 3.1.15 Premium allocations on recommended aggregates and service fees;
- 3.1.16 Compilation of detailed insurance manual as well as full summary on covers, limits, conditions, and exclusions;
- 3.1.17 Check and provide the issued policies as well as legal confirmation of statutory compliance;
- 3.1.18 Ad hoc adjustments and endorsements on sums insured and declarations to insurers/re-insures and issuing of accounts within 30 days of transactions;
- 3.1.19 Monitor premium payments and refunds in accordance with accounts and statement;
- 3.1.20 Ad hoc training where required in terms of policy and procedural manual.

Maintenance and administration of the insurance portfolio

- 3.1.21 Claim administration and maintenance;
- 3.1.22 Compilation of claims procedural manual
- 3.1.23 Day to day correspondence and queries;
- 3.1.24 Keep SANParks up to date with the latest amendments to the relevant legislation on Insurance through regular engagements, reports or workshops;
- 3.1.25 Maintain an electronic claims management system;
- 3.1.26 Attend site meetings for large or potentially large claims (All costs associated with such visits shall be for the broker's account and must be included in the servicing fee. SANParks may, at its discretion and subject to availability, provide accommodation at its cost within or in the vicinity of the affected Park in line with SANParks Travel Policy).

3.2 Classes of insurance

The service provider will be required to ensure adequate insurance covers for SANParks needs. The following are the current classes of insurance covers in place, and the estimated values (VAT inclusive). This information is to sensitize the bidder to the magnitude of the cover limits:

3.2.1 Property Damage (Assets)

To cover all properties of every description belonging to the SANParks, and such includes buildings and contents. Buildings and contents refer to All Buildings, and structures erected, and contents refers to items inside the buildings such as office desks, chairs, microwaves, beds, stoves, fridges, etc. Furthermore Additional items refers to items like bridges, tar roads, fences, and generators etc against theft, loss or damage caused by fire or allied perils, natural disasters.

- Current total insured value for Buildings and Contents: R10,8 billion
- Current total insured value for Additional items: R 5,9 billion
- For the details and split of the current insured values, refer to Annexure **H & I**

3.2.2 Business Interruption

It is an insurance cover that protects SANParks against loss of income when operations are disrupted due to an insured event. This should include but is not limited to, fixed expenses, operating expenses, and additional working expenses

- Current total insured value: R3 billion

3.2.3 Public Liability cover

It provides cover for the SANParks' legal liability to pay compensation for accidental bodily injury, death, or property damage suffered by third parties (members of the public) arising out of SANParks' business operations, premises, or activities.

- Current total insured value: R450 million per incident

3.2.4 Employment Practices Liability

Employment Practices Liability Insurance (EPLI) provides cover for SANParks' legal liability arising from employment-related claims made by employees, former employees, or job applicants.

- Current total insured value: R20 million per incident.

3.2.5 Directors and Officers liability

Directors and Officers (D&O) Liability Insurance provides financial protection to SANParks' directors, officers, and senior management against claims made against them for wrongful acts committed in the performance of their managerial duties.

- Current total insured value: R100 million annual aggregate

3.2.6 Motor Fleet

Cover for loss of or damage to insured vehicles and liability. All vehicles owned, operated, hired, leased, borrowed, or used or under the control of SANParks. All vehicles should be comprehensively insured.

- Current retail value of insured vehicles: R468,8 million
- Current number of vehicles: 1296
- Current vehicle with the highest value: MAN truck: R2,8 million

NB: The value of the fleet to be insured will be reduced significantly within the contract period years.

3.2.7 Fidelity Guarantee/ Commercial Crime

Cover for loss resulting from employee dishonesty, directly caused by one or more dishonest or fraudulent acts committed by any employee of SANParks, whether acting alone or in collusion with others, and wherever such acts occur. The cover includes loss of property arising from such acts, including but not limited to computer fraud, fraudulent transfer instructions, electronic data loss, and computer virus-related fraud.

- Current total insured value: R50 million per incident.

3.2.8 Group Personal Accident

Provides accidental injury cover for groups of individuals, such as employees, volunteers, or authorised participants of SANParks, under a single policy. It offers financial benefits if an insured person suffers accidental bodily injury resulting in accidental death, permanent total or partial disability, temporary disability, or accident-related medical expenses, while engaged in SANParks-related duties or activities as specified in the policy.

- Current Total Limit: Various, depending on various categories of people insured – Total number of people insured on this cover is 1 335

3.2.9 Electronic Equipment

Provides cover for the loss of or damage to electronic devices and systems owned, leased, or used by SANParks. This includes equipment such as computers, servers, communication systems, security systems, scientific and conservation-related instruments, audio-visual equipment, and other specialised electronics used in SANParks operations.

- Current total insured value: R25,3 million

3.2.10 Contractors all risk (CAR)

Provides comprehensive cover for accidental physical loss of or damage to construction works, materials, and equipment during the course of a project. It also includes cover for the contractor's legal liability to third parties for bodily injury or property damage arising from construction activities.

- Current total insured value: R5 million per contract

3.2.11 Marine

Provides cover for SANParks against loss of or damage to vessels, marine equipment, and watercraft owned or operated by SANParks, as well as cargo or equipment transported over water.

- Current total insured value: R13 million

3.2.12 Cyber liability

Provides cover for SANParks against financial losses, legal liabilities, and expenses arising from cyber-related incidents, including data breaches, cyber-attacks, or unauthorised access to SANParks' digital systems.

- Current total insured value: R50 million annual aggregate.

3.2.13 Commercial Professional Indemnity

Provides cover for SANParks against claims arising from professional services rendered, including advice, design, or consultancy, where an act, error, or omission results in financial loss to a third party.

- Current total insured value: R7,5 million per incident.

3.2.14 Artefacts

Provides cover for SANParks' tangible cultural, historical, or scientific items, including artefacts, specimens, fossils, artworks, and other irreplaceable objects owned, held, or exhibited by SANParks.

- Current total insured value: R4 million

3.2.15 Riot & Strike (SASRIA)

Provides cover for SANParks against loss or damage to property caused by political or civil unrest, including riots, strikes, civil commotion, public disorder, and malicious acts.

- Current total insured value: R500 million annual aggregate

3.2.16 Riot Wrap Around

Provides additional or complementary cover for SANParks for losses arising from riot, strike, civil commotion, and malicious damage, extending or "wrapping around" the coverage provided by the standard SASRIA policy.

- Current total insured value: R20 million per incident

3.2.17 Aviation Insurance:

Provides comprehensive cover for SANParks' aviation operations, including helicopters, fixed-wing aircraft, and drones. It protects against physical loss or damage to aircraft from accidents, fire, theft, or war risks (Hull All Risk & Hull War), covers legal liability for bodily injury or property damage to third parties and passengers (Third Party & Passenger Liability), and provides financial benefits to crew, passengers, or authorised personnel for accidental death, permanent or temporary disability (Personal Accident). The policy also covers SANParks' liability arising from incidents on airport or helipad premises (Airport Premises Liability) and from the operation of drones causing injury or damage to third parties (Third Party Drone Liability), ensuring full protection across all aspects of its aviation activities.

- Current total insured value: Refer to Annexure G

3.3 Claims history

The insurance claims history is only indicative to provide an understanding of the administrative scope of work based on past claims.

3.4 Special Conditions

- 3.4.1 Copy of bidders Standard Terms of Engagement (TOE) to be provided for SANParks consideration.
- 3.4.2 Proof of Professional Indemnity cover of a minimum of R1 billion. The successful service provider will be given seven days to produce proof of Professional Indemnity cover.
- 3.4.3 Service providers are not allowed to earn commission on premiums
- 3.4.4 Service provider must provide details of the proposed electronic claims management system, that will be used to administer SANParks portfolio, including the location from where maintenance and support will be provided. The system must be maintained and supported in South Africa.

THE BIDDING SELECTION PROCESS

Evaluation phases

Phase 1: Mandatory evaluation criteria

The bidder **must indicate its compliance / non-compliance** to the requirements and should substantiate its response/s with supporting evidence when indicating that they comply. Please ensure that the substantiation is clearly cross-referenced to the relevant requirement.

Failure to comply with Mandatory Requirements **shall lead** to the bidder being disqualified and not considered for further evaluation on the functionality / technical evaluation requirements.

Phase 2: Technical/Functional evaluation criteria

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
