1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite quotations for the valuation of assets for security review in respect of companies in the Manufacturing, Logistics, Healthcare, Retail and Dairy Industry in favour of the KZN Growth Fund Trust (KGFT).

2. BACKGROUND

KZN Growth Fund Trust (KGFT) is a Trust, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED

In preparation for the KGFT's year-end audit, an assessment of the valuation of assets held by KGFT of the project company, valuation of assets is required to be performed by a suitably qualified independent valuation experts. Such valuation will be relied upon by the KGFT's internal and external reporting.

The anticipated general scope of work in respect of the valuation will include but not limited to:
Verification of the registration of bonds at the deeds office and provide copies thereof.

- Physical verification of the assets* (photographic evidence to be included with the report)
- Verification of the registration of bonds at the deeds office and provide copies thereof
- Valuation amounts per asset on each of the following basis:
 - Replacement value for insurance purposes
 - Fair market value for accounting purposes
 - Forced sale value for liquidation purposes

Bidders must provide detailed proposal on each of above valuation approaches as part of their submission. Clearly state advantages and Disadvantages of the proposed valuation approaches.

4. CONTRACT DURATION

The contract relationship is expected to extend until all valuation queries have been resolved, valuations submitted for approval by Board of Trustees and AFS signed off on 31 August 2024.

5. AWARD OF THE RFP

KGFT is not obliged to accept and award this tender to the lowest bidder or any other bidder.

6. EVALUATION PROCESS AND CRITERIA

Selection will be conducted over three stages as detailed below:

- Stage 1 – Compliance with minimum requirements
- Stage 2 – Functionality Requirements
- Stage 3 – Price and Specific Goals

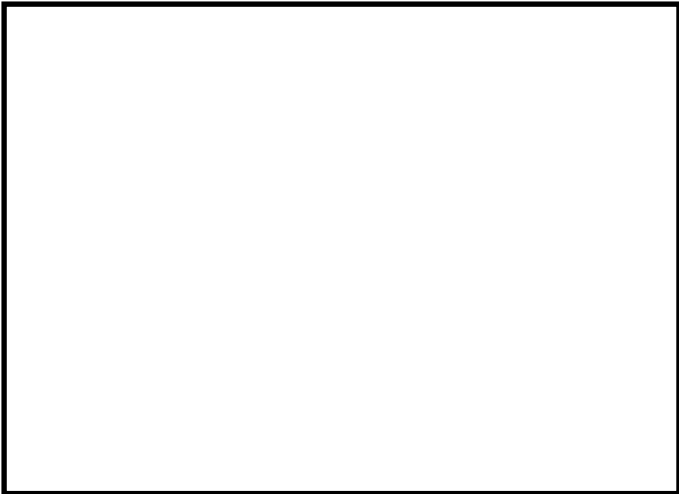

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
