3. Background

The Moses Kotane Institute (MKI) is an entity of the KwaZulu-Natal Provincial Government through the Department of Economic Development, Tourism and Environmental Affairs (EDTEA). Its mandate is to provide internationally recognised quality research driving the economic development and innovation in the province. It does this by providing timely and accurate research to support the attainment of radically transformed inclusive and sustainable economic growth for the province in partnerships with public and private sector.

4. Project objectives

The objective of this project is to ensure that the MKI has a world class accounting package that meets the needs of this diverse organization.

5. Scope of work

The supplier will provide a cloud-based accounting package that is compatible with Sage Evolution.

5.1. The expected outcomes and deliverables

The following specific output/outcome is expected during and on the completion of the project-

- a) Inception report detailing the approach and methodology of the intended online accounting package.
- b) Accounting package must be compatible with Sage Evolution, Sage Business Payroll.
- c) Package must have the following modules:
 - 1) Financial reporting – Must be customizable
 - 2) Budget management
 - 3) Project accounting
 - 4) Able to have sub accounts in the trial balance
 - 5) Document flow management for approvals, example purchase orders
 - 6) Able to upload documents to PO's that are sent for approvals.

- 7) Use of Dashboards
- 8) Regular updates
- 9) Updated security features

6. General process consideration

The service provider is expected to submit a proposal detailing the ability of the accounting package to meet all the requirements as listed above.

7. Timeframe and implementation schedule

The project is expected to be completed at the end of January 2022

8. Project costs

The services for the project will be funded by MKI. Proposal must also include project timeframe and total costs. The costs must be an all-inclusive (including disbursements, travel, stationery etc.).

- c) Team leader should have a minimum of 3 years' experience in similar or related assignments, grounded expertise in implementation and design
- d) A summary of the organisation's experience in providing the kind of deliverables called for in these terms of reference.
