## 1. PURPOSE

The purpose of this request is to appoint a service provider for the supply and installation of 25 aircons in the Tsitsikamma Section of Garden Route National Park.

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

## 3. SCOPE OF WORK

The scope of works entails the supply, delivery, installation, testing, commissioning and handover of twenty-five (25) split unit air conditioning systems at various buildings within Tsitsikamma National Park.

The service provider shall provide all labour, materials, tools, equipment, transport and supervision necessary for the complete installation and commissioning of the air conditioning units.

The successful bidder shall inspect each installation location and verify all dimensions, electrical requirements and mounting conditions prior to commencement of works.

All installations shall comply with the Occupational Health and Safety Act, SANS 10142, manufacturer's specifications and all applicable South African regulations and standards.

The contractor shall include for:

- Supply and installation of air conditioning units.
- Supply and installation of indoor and outdoor units.
- Mounting brackets and supports.
- Refrigerant piping and insulation.
- PVC condensate drainage piping.
- Trunking and pipe covers.
- Electrical cabling and interconnecting wiring.
- Isolators and circuit protection.
- Core drilling and wall penetrations.
- Weatherproof sealing of all penetrations.
- Testing and commissioning of all units.
- Refrigerant charging where required.
- Demonstration of operation to SANParks representatives.
- Removal of all installation debris from site.
- Provision of manufacturer's warranties and commissioning certificates.
