1.1 DESCRIPTION OF SERVICE:300 MM BOUDON TENSIMETERS (COMPLETE SET)

BACKGROUND: This is a new Water Research Commission (WRC) project that started in April 2022. The project is entitled "Effect of irrigation and harvesting age on the growth, yield and chemical composition of *Pelargonium sidoides* DC.". Tensiometers are needed to measure soil water at the root zone of plants.

PURPOSE: The project focusses on the irrigation requirements of this medicinal plant and the effects of irrigation and harvesting age on plant yield and soil properties. The research will be carried out as a pot study. *P. sidoides* is one of the species of the genus *Pelargonium* that is commonly used by several ethnic groups in South Africa. It is a popular medicinal plant used in traditional medicine for the treatment of respiratory tract infections and gastrointestinal ailments. Like many other medicinal plants, *P. sidoides* has experienced extensive wild harvesting of the wild-growing species due to the increasing international demand. The increased rate of wild harvesting diminishes the natural population, thus, making the exploitation of *P. sidoides* unsustainable. To ensure sustainable harvest and prevent depletion of the wild population, cultivation of this medicinal plant is seen as one of the ways out of these challenges. However, water is needed for a successful cultivation. Information on the water use of *P. sidoides* in a water-challenged country like South Africa is still very scanty. Thus, understanding the water needs of the crop is an important factor in designing appropriate irrigation management that will ensure optimum productivity. This way, pressure on the wild populations can be reduced. Therefore, to determine water use of *P. sidoides*, tensiometers will be required. Each experimental unit will be fitted with a tensiometer to monitor soil water deficit at the root zone. The success of this project is attached to this equipment (tensiometers). This will enable the research project to capture data on the water use efficiency of the plant. After the completion of the project, these tensiometers will be used for future research projects that will require the monitoring of soil water contents.

SCOPE OF WORK: This is a three (3) year project which starts on 01 April 2022 and end on 31 March 2025. ARC researchers and post graduate students will be involved with the project.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
