- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

Background

The ARC requires a twenty-four (24) months collection & thermal treatment/ disposal of biohazard, pharmaceutical, chemical & ash waste contract for two (2) campuses, namely: ARC-Irene & AP-Roodeplaat. These services are fundamental to ensuring health, safety, waste, legal obligation & minimizing the risk of pollution and biohazard infections.

1. Technical Requirements

1.1. Provide & furnish with a valid Waste Management Licence in terms of Section 45 of the National Environment Management Waste Act 59/2008 (as amended) for hazardous waste as per following:

- Waste information registration number (**WIR number**), will be an added advantage. (Proof to be included with the bid proposal)
- Name of waste management company/person/entity
- The date of company registration
- Business Licence category (**A**: require a basic assessment process in terms of the environmental impact assessment (EIA) regulations, or **B**: require a full assessment report in terms of the EIA regulations)
- The service provider should be the original licence holder & no third party licences will be accepted
- A registration certificate as a waste treatment facility with Dept of Forestry, Fisheries & Environment in terms of Section 49(1) of the NEM: Waste Act 59/2008.
- If registered as waste transporter, bidders shall provide proof of license as a hazardous goods transporter in terms of SANS 10406,
- If accredited for hazardous goods transportation, furnish with a written service contract/MOU with an accredited thermal treatment facilities

1.2. Ensure that vehicles used for the collection and transportation of hazardous waste are constructed to ensure safety of goods during transportation and display mandatory markings. Furthermore documentation relating to the source, transportation and disposal of hazardous waste must be in accordance with the conditions of an accreditation permit or waste management licence issued to the “registered person/licence or permit holder” under the:

- National Road Traffic Act 93/1996
- Hazardous Substances Act 15/1973
- National Environmental Management: Waste Act 59/ 2008

1.3. Must provide valid letter of good standing with Compensation Commissioner.

2. Deliverables

- Bi-monthly collection (once every 2 months), transportation & thermal treatment of biohazard, chemical, & pharmaceutical waste,
- Bi-monthly (every 2 months) collection, transportation & disposal of ash waste (when required),
- Weekly collection of poultry waste (when required),
- Provision of written quarterly project report & waste destruction certificates,
- Provision & replacement of proper labelled bins & lining material for temporary waste containment,
- Ensure compliance with NEM: Waste Act, SANS 10406, SANS 10248 & SANS 10228.
- Utilize competent persons & proper transportation for the handling, collection & transportation of dangerous goods.
- Utilize DEA & GDARD accredited treatment facilities for treatment of hazardous waste.
