PACOFS requests service providers to submit proposals to provide bar services in a variety of its venues while rental and artistic productions are hosted. The entity is inviting service providers to provide bar services during productions in the bars of Theatres such as, Sand du Plessis theatre, Andre Huguenet theatre and Sengagata venue for a 1 year period. The bar must be open an hour before productions, during intervals when applicable, and also for 30-60 minutes after productions. The PACOFS venues are situated in 12 First Avenue, Bloemfontein for a period of 1 year.

PACOFS requires a service provider that will ensure that our visitor experience is enriched, that there is no long queues in front of the bars and that a variety of alcohol, fit to the specific needs of the audience of the specific production, is provided. The bar services should be aligned with industry standards and best practices. The service provider has to bring its own fridges, ice machines, glasses and other equipment, e.g. barista coffee machines, as well as stock. Gin and craft beer on the tap will be a great add-on to stock. The equipment and stock will be locked safely in the bars between productions.

## Duties and responsibilities of service provider:

- Buying all bar stock
  - Providing bar services for stage productions in the bars of the theatres, as well as function venues of PACOFS
- Keeping the purchase and sales information that might be required.
- Cleaning the bar and all items with cleaning chemicals in line with health and safety regulations.
- Provide monthly operational reports for profit share

## Requirements

- A minimum of 3 years experience as a bar management business at events with more than 800 people in a fast-paced environment
- A valid liquor license
