A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R200-00 including VAT** for hard copies directly printed by the Municipality and free of charge when provided on pdf via e-mail. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Only locally produced or locally manufactured goods with a minimum threshold for local production and content will be considered:

- **Steel related products & parts 100%**
- **Parts / Material: PVC, Plastics, Rubber, hoses included 100%**
- **Valves 70%**

The exchange rate used to calculate local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the 11 August 2022

Formal Tender TD-27/08/2022 will be evaluated and adjudicated in terms of **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2017) and the Municipality's Supply Chain Management Policy.
