- 1.3. **PRESCRIBED IN THE BID DOCUMENT.**

### NOTICE TO BIDDERS

#### 1. RESPONSES TO RFQ

Responses to this RFQ [**Quotations**] must not include documents or reference relating to any other quotation or proposal. Any additional conditions must be embodied in an accompanying letter.

Proposals must reach the PRASA before the closing hour on the date shown on SBD1 above, and must be enclosed in a sealed envelope.

All responses to the RFQ must be submitted in two sealed envelopes/boxes; the first envelop/box shall have the technical, compliance and BBBEE response and the second envelop/box shall only have the financial response. Bidders must ensure that they do not indicate any financial information in the first envelop/box. PRASA will disqualify Bidders who fail to adhere to this requirement.

1.1 Bidders are required to package their response/Bid as follows to avoid disqualification:

##### **Original & Copy of Volume 1 (Envelope 1/Package 1)**

- **Part A:** Compliance Response and B-BBEE Response
- **Part B:** Technical or Functional Response (response to scope of work) and SBD 6.2 and Annexure C

##### **Original & Copy of Volume 2 (Envelope 2/ Package 2)**

- **Part C:** Financial Proposal (BOQ/Price Schedule and Pricing form C)

**Volume 2** Has to be submitted in a separate sealed envelope. Bidders must make their pricing offer in envelope 2/package 2, no pricing and pricing related information should be included in the Volume 1/envelope 1. **Bidders who fail to meet this requirement will be automatically disqualified.**

#### 2. PREQUALIFICATION / ELIGIBILITY CRITERIA

2.1 Only those Respondents who satisfy the following pre-qualification or eligibility criteria are eligible to submit quotations as per section 3.

#### 3 CIDB Grading

Only those Respondents who are registered with the CIDB, or are capable of being so prior to the submission of the quotation, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered or a value determined in accordance with Regulation 25 (1B)

or 25(7A) of the **Construction Industry Development Regulations, for a 1ME or higher** class of construction works, are eligible to have their quotations evaluated.

Joint ventures are eligible to submit tenders provided that:

- every member of the joint venture is registered with an active CIDB;
- the lead partner has a higher or equivalent contractor active grading designation in the class of construction work; and
- the combined Contractor active grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a Contractor grading designation determined in accordance with the sum quoted for a .... class of construction works or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations

#### **4 COMMUNICATION**

Respondent/s are warned that a response will be liable for disqualification should any attempt be made either directly or indirectly to canvass any SCM Officer(s) or PRASA employee in respect of this RFQ between the closing date and the date of the award of the business.

#### **5 LEGAL COMPLIANCE**

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

#### **6 CHANGES TO QUOTATIONS**

Changes by the Respondent to its submission will not be considered after the closing date and time except on condition of correcting arithmetic errors on BOQ

#### **7 PRICING**

All prices must be quoted in South African Rand on a fixed price basis, including VAT.

#### **8 BINDING OFFER**

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

## 9 DISCLAIMERS

PRASA is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that PRASA reserves the right to:

- Modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- Reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- Disqualify Quotations submitted after the stated submission deadline;
- Not necessarily accept the lowest priced Quotation or an alternative bid;
- Bids lodged at the incorrect venue that reach the correct venue late will be regarded as late.
- Reject all Quotations, if it so decides;
- Place an order in connection with this Quotation at any time after the RFQ's closing date;
- Make no award at all.
- Award only a portion of the proposed goods / service/s which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider should it at PRASA's discretion be more advantageous in terms of, amongst others, cost or developmental consideration; or

Should a contract be awarded on the strength of information furnished by the Respondent, which after conclusion of the contract, is proved to have been incorrect, PRASA reserves the right to cancel the contract. PRASA reserves the right to award business to the highest scoring bidder/s unless objective criteria justify the award to another Respondent.

## 10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by PRASA's Legal Counsel, prior to consideration for an award of business.

## 11 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. PRASA is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to

## **12 PROTECTION OF PERSONAL DATA**

In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. PRASA agrees that it shall only process the information disclosed by Respondents in their response to this bid for the purpose of evaluating and subsequent award of business and in accordance with any applicable law.

Furthermore, PRASA will not otherwise modify, amend or alter any personal data submitted by Respondents or disclose or permit the disclosure of any personal data to any Third Party without the prior written consent from the Respondents. Similarly, PRASA requires Respondents to process any personal information disclosed by PRASA in the bidding process in the same manner.

### 14 ADMINISTRATIVE RESPONSIVENESS

The test for administrative responsiveness will include completeness of response and whether all returnable and/or required documents, certificates; verify completeness of warranties and other bid requirements and formalities have been complied with. Incomplete Bids will be disqualified.

### 15 VALIDITY PERIOD

- 15.1 PRASA requires a validity period of **60 Business Days** from the closing date.
- 15.2 Respondents are to note that they may be requested to extend the validity period of their response, on the same terms and conditions, if the internal processes are not finalized within the validity period. However, once the adjudication body has approved the process and award of the business to the

successful respondent(s), the validity of the successful respondent(s)' response will be deemed to remain valid until a final contract has been concluded.

## SECTION 5

2.6 “**Black People**” meaning assigned to in Section 1 of Broad-Based Black Economic Empowerment Act.

2.7 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);

2.11 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;

2.12 “**co-operative**” means a co-operative registered in terms of section 7 of Cooperatives Act, 2005 (Act No. 14 of 2005)

- 2.13 **“Designated Group”** means - i) Black designated groups; ii) Black People; iii) Women; iv) people with disabilities or v) Small enterprise, as defined in Section 1 of National Small Enterprise Act, (102 of 1996)

- 2.24 **“Proof of B-BBEE Status Level of Contributor”** i) the B-BBBEE status level certificate issued by an unauthorised body or person; ii) a sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or iii) any other requirement prescribed in terms of the Broad- Based Black Economic Empowerment Act.
- 2.25 **“Rural Area”** i) a sparsely populated area in which people farm or depend on natural resources, including villages and small towns that are dispersed through the area; or ii) an area including a large settlement which depends on migratory labour and remittances and government social grants for survival, and may have traditional land tenure system.

affidavit from CIPC (formerly CIPRO) Self Service Terminals when registering a business or filing annual returns. In these instances PRASA would require proof of turnover as well as proof of ownership. - v) If a bidder submitted false information regarding its B-BBEE status level of contributor, local production and content, or any other matter required in terms of the Preferential Procurement Regulations, 2017 which will affect or has affected the evaluation of a bid, or where a bidder has failed to declare any subcontracting arrangements or any of the conditions of contract have not been fulfilled, the purchaser may, in addition to any other remedy it may have.
  - (a) disqualify the person from the bidding process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) if the successful bidder subcontracted a portion of the bidder to another person without disclosing it, PRASA reserves the right to penalise the bidder up to 10 percent of the value of the contract;

  - (f) forward the matter for criminal prosecution.

### SCOPE OF WORKS

#### 2. INTRODUCTION

The purpose of this submission is to obtain approval to procure a Service Provider for maintenance, servicing and repairs to **shutter gates, boom gates and sliding gates** for the WESTERN CAPE REGION (WCR).

The contract work consists of:

- Unplanned /Emergency general shutter gates, boom gates and sliding gates related repairs as and when required. (Refer **to scope of work for details**)

The contractor shall integrate the provision of his services into the general operation of the PRASA operational system which may require that the contractor co-operate with other contractors employed by PRASA.

#### 3. BACKGROUND INFORMATION

##### a. STATUS QUO

PRASA is mandated to transport commuters to and from various stations, these stations operate for as long as there are trains running, after the last train they have to be shut down by closing off of all the entry points. This is done by means of rolling down the shutter gates, closing of sliding gates, at the depots there are also boom gates. There is also an increase in the vandalism of our assets and facilities; an extra measure to assist the security is by having fully functional gates (shutters, sliding or boom).

To keep these functional and operational all the time and there should be maintenance contract which services them as they are required and also attending to repairs when necessary in accordance with applicable regulations to ensure they are operating safely at any given time. The nature of the contracts is;

- monthly maintenance and servicing of the roller shutter gates and
- “As and when required” repairs to the equipment following failures and non-functionality to restore to sound operational state.

##### b. PROBLEM STATEMENT

- The Western Cape Region has been exposed to high rate of recurring theft and vandalism which resulted to non-functional and non-compliant PRASA assets that poses safety and health hazard to the commuters, PRASA personnel, stakeholders and community at large. Malicious damages to PRASA properties and assets
- The Region doesn't have internal staff to execute emergency repairs and unplanned maintenance.

## Western Cape Railway Diagram




Figure 4.1: Western Cape Rail-network

### 4. OBJECTIVE OF THE PROPOSED PROJECT

#### a. DESIRED OUTCOMES FOR CARRYING OUT THE PROPOSED PROJECT

- To improve response time for execution of unplanned shutter gates, boom gates and sliding gates maintenance works in order to restore the assets to its operational condition and further achieve the goal of improving asset condition and reliability.
- Compliance with the Occupational Health and Safety Act, Railway Safety Regulator and other statutory requirements.

#### b. PROJECT BENEFITS TO PRASA

- Increased revenue collection
- Improved turnaround time to repair faults
- Improve compliance with legislation and safety requirements

- Improve customer satisfaction.

**c. CURRENT MECHANISMS IN PLACE TO ADDRESS THE PROBLEM**

The Region currently has no internal staff to service the entire Region with more than 121 stations excluding Workplace facilities.

**5. SCOPE OF WORK AND AREAS OF FOCUS**

**a. SCOPE OF THE DESIRED SOLUTION**

To appoint a shutter gates, boom gates and sliding gates contractor on an As and When basis to repair and maintain the facilities for a period of 36 months in the Western Cape Region (WCR).

The scope of works will cover repairs and maintenance as required, but not limited to the following shutter gate related works as noted below.

- The successful Service Provider is expected to be available to respond twenty-four (24) hours per day, seven (7) days per week, 365 days per year, as determined by the nature of a given situation and/or emergency.
- The type of work the Service Provider will respond to will include, but is not limited to, repair of faulty, broken, vandalised or stolen roller shutters, sliding and boom gates, i.e. electric motors, T-Bars or damaged slats.

**Additional information**

- The service provider should provide vehicles suitable for the execution of the operations.
- Suitable vehicles are “bakkies” or light duty trucks for the transportation of employees and materials and to respond to callouts.
- The service provider should have a workshop or office close to the stations in order to respond timeously to the callouts.
- During the contract term the Contractor shall furnish all parts, materials, tools, equipment, manpower, and consumables to complete the work.
- The repair parts used by the Contractor shall be new and unused. The Contractor is responsible to provide new parts and execute the repairs.
- If the unit is beyond repair a delegated PRASA official will examine the component and provide authorization for the purchase of a new component.

### a. DETAILS ON THE PREFERRED SOLUTION

The preferred solution shall address the issue of the absence of internal staff to response to emergency repairs and unplanned maintenance.

### b. TARGETED AREA BY THIS PROJECT

- The request is to appoint a contractor to cover the Southern corridor, Northern corridor, Ikapa and central corridor inclusive of all workplace facilities as presented in the table below.
- The Southern corridor comprises of 37 stations
- The Northern corridor comprises of 52 stations
- The Central corridor comprises of 21 stations
- The Ikapa corridor comprises of 11 stations and 1 Depot

## 6. SPECIFICATION OF THE WORK OR PRODUCTS OR SERVICES REQUIRED

### a. SPECIFICATION- AS AND WHEN: ROLLER SHUTTER GATES, SLIDING GATES AND BOOM GATES REPAIRS AND MAINTENANCE.

#### PREAMBLE

PRASA CRES Facilities department has a mandate to the general upkeep of PRASA Group Facilities here in referred to as all buildings, plants and equipment's. In its endeavor to achieve the said mandate its service provisions cover the following:

- Preventative Maintenance
- Periodic Maintenance
- Routine Maintenance
- Deferred Maintenance
- Reactive Maintenance

#### With the following Priority Levels:

- Emergency- an incident that threatens endangers personal safety or property and prevents or limits the usage of a building, plant and equipment.
- Urgent – an incident that does not threatens, endangers personal safety or property but does prevents or limits the usage of a building, plant and equipment.
- Non-Urgent- an incident that is defined or falls under the general repairs, deferred maintenance or reactive maintenance of a non-urgent nature, where a building, plant and equipment is secured and use of it is not disrupted.

#### Service performance measurements and expectations

- **Emergency & Urgent Faults** - Response time for non-emergency items shall be 24 hours from the call out time and completion as per marked related time to repair the fault as per job card or work order.
- **Normal Faults** - Response time for non-emergency items shall be within working days stipulated in the works order from the call out time and completion as per marked related time to repair the fault.

#### Completion of works, upon the completion of work the service Provider must submit the following:

- Signed job card by the Project Manager or leader (job completion form)
- Guarantee/ Warranty certificates to cover a free maintenance period
- Maintenance programs or plan for
- New installations for shutter gates, boom gates and sliding gates related items.
- Maintenance manuals
- Related statutory / regulatory documentations

**Safety and Quality of Materials and Workmanship:**

- All materials supplied to be SABS approved and workmanship to meet the requirements of the PRASA Norms, Guidelines and Standards (NGS) and the National Building Regulations (NBR).
- All work performed on PRASA premises to comply with the requirements of the Occupational Health and Safety Act of 1993.
- The successful bidder shall be required to comply with the regulations issued in terms of the Disaster Management Act in relation to COVID-19.
- Works with poor workmanship will not be signed off and PRASA CRES reserve the right to withhold payments until satisfied with the quality of the works.
