A. INTRODUCTION TO THE REQUEST FOR PROPOSAL (RFP)

1. Introduction

- 1.1. The Export Credit Insurance Corporation of South Africa (SOC) Limited (ECIC or Corporation)¹ is a self-sustained state-owned entity listed under Schedule 3B of the Public Finance Management Act 1 of 1999 (as amended) and established in terms of the Export Credit and Foreign Investments Insurance Act 78 of 1957 (as amended).
- 1.2. The mandate of ECIC is to facilitate and encourage South African export trade by underwriting export credit loans and investments outside the country, to enable South African contractors to win capital goods and services contracts in countries outside South Africa. ECIC is a registered Financial Service Provider and is regulated by the Financial Sector Conduct Authority and Prudential Authority (FSP No: 30656). Currently exempted in terms of FAIS Notice 78 of 2019.

2. Background

- 2.1. ECIC occupies the 4th floor of the offices at the address indicated in paragraph 1.3. The total floor area is approximately 2 294^m². The offices are in the Byls Bridge Office Park
- 2.2. Currently, ECIC has two security desks to assist clients and suppliers (one is situated next to the lifts on the ground floor, and one is situated on the fourth floor next to the reception area. During the day shift, one security guard will be required to be on duty on the ground floor and one guard on the fourth floor. During the night shift, only one security guard will be required and will be stationed on the fourth floor.

3. Purpose

- 3.1. Bids are hereby invited to provide armed guarding services to ECIC for a period of five years.

4. Pre-qualifications

- 4.1. ECIC will not award this bid to a bidder who is:
 - 4.1.1. Not registered as a security service provider with the Private Security Industry Regulatory Authority.

Terms of Reference

4.1.2. Not remunerating their employees in line with the requirement of the Collective Agreement concluded in the National Bargaining Council for the Private Security Sector, issued in the Government Gazette No. 47797 under Notice 1530 of 2022 dated 30 December 2022 (or any successor in title).

4.1.3. Not compliant with COIDA (Compensation for Occupational Injuries and Diseases Act) requirements and not registered with the Workmen's Compensation Fund.

4.2. The disqualification process and requirements under this paragraph 4 is fully detailed and explained in paragraph 11.

5. Pricing

5.1. ECIC will not appoint a bidder who does not remunerate its employees in line with the minimum salary as set out in the latest Collective Agreement concluded in the National Bargaining Council for the Private Security Sector (inclusive of any amendments thereof).

5.2. In response to this bid, bidders are required to provide their illustrative pricing, including the hourly rate payable to the security guards. Failure to provide the hourly rate payable will result in the bidder's disqualification during the pre-qualification evaluation stage. It is a condition of this contract that the appointed bidder's remuneration to the security guards must include, at a minimum, the following items:

5.3. To ensure that the bidder's pricing includes the minimum items indicated in Table 1, bidders are required to consult the illustrative pricing guide published by the National Bargaining Council for the Private Security Sector, which can be accessed from:

6. Procurement Regulations

- 6.1. This bid is subject to the Preferential Procurement Policy Framework Act No. 5 of 2000 and the Preferential Procurement Regulations, 2022, the General Conditions of Contract (GCC) and, if applicable, any other special conditions of contract. Where, however, the special conditions of the contract conflict with the general conditions of the contract, the special conditions of the contract prevail.

B. TERMS OF REFERENCE

7. Scope of services

7.1. The appointed bidder will be required to provide armed guarding services to ECIC (including but not limited to):

7.1.1. Providing security 24 hours a day, seven days a week, 365/366 days per year.

7.1.2. Access control, guarding of premises, patrolling of premises, escorting of service providers, protection of employees, protection of property, protection of ECIC assets and ECIC staff's personal belongings, protection of visitors and their personal belongings, protection of information, and execute other security functions as required by the ECIC.

7.1.3. Recording of incidents/events in an occurrence register and reporting such incidents /events to the ECIC. Bring any security deficiencies, problems or crime risks to the attention of the ECIC.

7.1.4. Monitoring of CCTV cameras.

7.1.5. Monitoring of the intercom in the basement and providing access to ECIC visitors on request.

7.2. The specific duties of security personnel in respect of the premises shall be as described in the duties of security personnel and Standard Operating Procedures (SOPs). These SOPs should be compiled by the preferred bidder in conjunction with the ECIC one week prior to the commencement of duties.

7.3. Personnel requirements

7.3.1. The personnel required will be as follows:

7.3.2. The total number of staff members required excludes relief personnel.

NB: The number of security officers indicated above is a reflection of ECIC's current requirements. ECIC reserves the right to increase or decrease the number of security officers as and when the security requirements change.

7.4. Tools of trade

NB: All the above equipment must always be kept on-site (ECIC offices) for the duration of the contract and fully operational.

7.4.2. Security Uniform

7.4.2.1. Security officers are required to be dressed in bidder's corporate uniform and must have the following:

The equipment and uniform must be quoted for in the bid proposal. If not quoted, the ECIC shall not allow a fee/cost adjustment after the award.

7.5. Other related security services

7.5.1. Preparation and submission of detailed site and incident reports on a monthly or ad-hoc basis.

7.5.2. Attend meetings as and when required.

7.5.3. Compliance with all laws, by-laws, rules and regulations applicable to the services to be executed by the appointed bidder.

7.5.4. Ensuring response times and submission times in respect of service.

7.6. Training

- 7.6.1. The service provider is responsible for the training of security officers for the duration of the contract.
- 7.6.2. ECIC reserves the right to request proof of training for each security officer as and when required during the duration of the contract.
- 7.6.3. All security staff that will be placed on-site at ECIC for the duration of the contract should be trained and knowledgeable about ECIC procedures and Standard Operating Procedures (SOP).

7.7. Other

- 7.7.1. The appointed bidder will also be expected, on an ad hoc basis, to perform other security functions as and when required by ECIC. These functions may be expected to be performed outside the ECIC head office if and when a need arises.

8. Conditions of award/contract

- 8.1. Bidders are required to submit their qualifications and firearm certificate. ECIC reserves the right to verify the qualifications and firearm competency certificate of security personnel and check their criminal records status with the relevant authorities.
 - 8.2. ECIC will not award a bid to a bidder:
 - 8.2.1. Who does not have a Public Liability Cover of at least R1 million. Bidders are required to provide proof of the Public Liability Cover. If a bidder is appointed as a service provider, they will be required to maintain the minimum cover required for the duration of the contract.
 - 8.2.2. Who is not a member of the Private Security Sector Provident Fund, or any other retirement fund as duly exempted or approved. The identified bidder will be required to provide evidence that they comply with the set requirements of the Private Security Sector Provident Fund, or any other retirement fund as duly exempted or approved, and their contributions are up to date. If a bidder is appointed as a service provider, they will be required to maintain compliance for the duration of the contract.
 - 8.3. The labour component of the contract will be subject to the applicable adjustments published by the Minister of Labour and Employment (or equivalent) after the end of the term of the current Collective Agreement concluded in the National Bargaining Council for the Private Security Sector.
- ## 9. Due diligence/site inspection
- 9.1. At the ECIC's discretion, a due diligence and/or site inspection may be conducted on the identified bidder. ECIC will visit the identified bidders' premises or bidder's client (with permission from the bidder) with the objective of verifying information as contained in their respective bid documents.

9.2. Where applicable, the ECIC will issue criteria for the due diligence review or site inspection beforehand to the applicable bidder(s). Should it be discovered during a due diligence visit or site inspection that the information submitted by the identified bidder is inconsistent with what is on their current premises of business, ECIC reserves the right to disqualify such bidder.

9.3. ECIC may identify another bidder using the next highest points obtained in the evaluation phase as stipulated in paragraph 9, taking into consideration the process followed under paragraphs 9.1 and 9.2.

10. Bid evaluation

10.1. The proposals will be evaluated in phases as highlighted below and detailed in paragraphs 11 to paragraph 15 of this document:

10.1.1. Phase One: Compliance

In this evaluation stage, bidders are expected to submit proposals that are in line with the requirements of this bid in all material respects. If the proposal submitted is not in line with the requirements of this bid, the proposal will be considered an unacceptable bid and will be disqualified from further evaluation.

10.1.2. Phase Two: Pre-qualification

In this phase, bidders are required to meet the pre-qualification requirements as detailed in paragraph 11.

10.1.3. Phase Three: Functional evaluation (Desktop evaluation)

In this evaluation phase, bidders are expected to obtain a minimum of 80 out of 100 points to proceed to the next evaluation stage of the evaluation. Failure to obtain the prescribed minimum points will automatically disqualify the bid offer from proceeding to the next evaluation phase.

10.1.4. Phase Four: Preference point system

The 80/20 preference point system shall be applicable to this phase, where 80 points represent the maximum obtainable points for the lowest acceptable price and 20 points represent maximum obtainable points for Specific Goals. Points will be awarded to a bidder for attaining the Specific Goals in accordance with the table as listed in the bid documentation (refer to paragraph 13, read together with the table on **page 33 (paragraph 4.1)**).

10.1.5. Phase Five: Objective criteria

ECIC will apply objective criteria as detailed in paragraph 15.

11. Evaluation Phase Two: Pre-qualification

11.1. The bidder must be validly registered with the Private Security Industry Regulatory Authority (PSIRA) and must provide proof of registration with the PSIRA. ECIC will verify

the proof of registration on the website of PSIRA for validity and compliance. If the bidder is not validly registered with PSIRA or not compliant with the requirements of PSIRA, the bid will be considered non-compliant.

- 11.2. The bidder must adhere to the most recent Collective Agreement concluded in the National Bargaining Council for the Private Security Sector. The bidder's quotations must indicate the hourly rate they will be paying their employees to be placed at ECIC. ECIC will compare the hourly rate quoted (provided) against the Collective Agreement concluded in the National Bargaining Council for the Private Security Sector. If the hourly rate quoted is less than the latest minimum rate payable, the bid will be considered non-compliant.
- 11.3. The bidder must be compliant with COIDA (Compensation for Occupational Injuries and Diseases Act) and must be validly registered with the Workmen's Compensation Fund. Bidders must provide a copy of a valid letter of good standing or the certificate number of the letter of good standing from the Workmen's Compensation Fund. The certificate number will be verified against the Department of Labour (or the Workmen's Compensation Fund) website. If the provided letter of good standing or the certificate number of the letter of good standing from the Workmen's Compensation Fund is not valid, the bid will be considered non-compliant.
- 11.4. Where a bidder fails to meet the pre-qualification requirements as listed in paragraphs 11.1 to 11.3, the bid will be considered an unacceptable bid and will be disqualified from further evaluation.

12. Evaluation Phase Three: Functional

- 12.1. The proposal submitted by the bidder will be evaluated by the ECIC based on the following criteria and be rated as the factor score over 5 multiplied by the applicable points:
- 12.2. Factor scores: 0=Poor, 1=Below average, 2=Average, 3=Good, 4=Very Good, 5=Excellent

12.4. Bidders are expected to obtain a minimum of 80 out of 100 points to proceed to the next evaluation stage of the evaluation. Failure to obtain the prescribed minimum points will automatically disqualify the bid offer from proceeding to the next evaluation phase.

Terms of Reference

13. Evaluation Phase Four: Preference point system

13.1. The formula below will be used to calculate the lowest acceptable bid price:

$$P_s = 80 \left(1 - \frac{P_t - P_{min}}{P_{min}} \right)$$

Where

P_s = Points scored for price of tender under consideration;

P_t = Comparative price of bid or offer under consideration; and

P_{min} = Price of lowest acceptable tender.

13.2. Depending on the bidder's level of Specific Goals, a maximum of 20 Specific Goals points may be awarded to a bidder. The points scored by a bidder for Specific Goals will be added to the points allocated for price.

13.3. The table below reflects the number of points to be allocated to a bidder for Specific Goals:

- 14.2. Any bid received from a bidder who did not provide the document requested in this paragraph 14 and do not indicate the number of Specific Goals they are claiming for in the SBD6.1 Form, **in the table on page 33 (paragraph 4.1)** shall be awarded zero points for Specific Goals (i.e. both the document required to substantiate the Specific Goals Claimed and the SBD6.1 must be submitted with response to this bid).
- 14.3. Points for Specific Goals will be allocated as indicated in paragraph 13 of this RFP and in the SBD 6.1 Form. Bidders are required to indicate how they claim points for each preference points on the SBD6.1 Form, **in the table on page 33 (paragraph 4.1)**. In the event that a bidder does not indicate the preference points they are claiming, the bidder will be awarded zero (0) points for Specific Goals.

15. Phase Five: Objective criteria

- 15.1. In this evaluation stage, ECIC will check if the bidder has a person who meet the following criteria in awarding the bid:
- 15.1.1. The bidder has a significant shareholder or owner (or equivalent) (directly or indirectly) who is classified or can be classified as a Prominent Influential Person (PIP) in accordance with Financial Intelligence Centre Act, 38 of 2001 (FICA).
- 15.1.2. The bidder has a shareholder or member or owner or director (or equivalent) who has questionable integrity status.
- 15.1.3. The bidder has a director or equivalent who is classified or can be classified as a PIP in accordance with FICA.
- 15.2. Should it be found during this evaluation stage, that the bidder who has attained the highest points under Evaluation Stage Four (Preference Point System) has persons listed in paragraphs 15.1.1 to 15.1.3, ECIC reserves the right to conduct further due

diligence on the person(s). Should the outcome of a further due diligence not be satisfactory to ECIC or such a person(s) poses an unacceptable high risk reputation and/or integrity of the person(s) be questionable, ECIC reserves the right not to award the bid to that bidder. This process may be repeated to the next bidder if so required.

17. Instructions to respondents

17.1.3. All questions must reference specific paragraph numbers, where applicable.

18. Timeline of the bid process

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2 DEFINITIONS

- 2.1 “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- 2.2 “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- 2.3 “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- 2.4 “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- 2.5 “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
