Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

The primary objective of DTPC is to undertake a routine inspection, cleaning and repairs on ponds. DTPC therefore invites suitably experienced and qualified service providers to quote for the provision of services to execute inspection, cleaning and repairs on the floating covers and HDPE liners of the ponds for a period of three (3) years.

The scope includes yearly inspection, cleaning and ad-hoc repairs of the pond covers and liners with associated ancillary components.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points (Specific Goals) will be allocated to the following as included in the bid document:

- I. Enterprises (or bidders) who are at least 51% or more Owned by Black People (10 points);
- II. Enterprises within KZN Region (10 points)
