PROSPECTIVE BIDDERS ARE HEREBY INVITED TO A COMPULSORY VIRTUAL BRIEFING SESSION TO BE HELD ON 11 APRIL 2024 AT 10:00AM. THIS IS A FOLLOW UP BRIEFING SESSION TO THE ONE HELD ON 26 MARCH 2024. PROSPECTIVE BIDDERS EXPERIENCED CHALLENGES IN ACCESSING THE BRIEFING SESSION BEFORE, DURING AND POST.

THIS ISSUE HAS LED THE DEPARTMENT HAVING TO ARRANGE ANOTHER COMPULSORY VIRTUAL BRIEFING SESSION, THIS IS IN KEEPING WITH THE PRINCIPLES ENshrined IN THE CONSTITUTION SECTION 217 AND TO AVOID FUTURE LITIGATIONS.

THE ARRANGEMENT OF ANOTHER COMPULSORY BRIEFING SESSION HAS ALSO AFFECTED THE ADVERTISEMENT PERIOD OF THE BID, THIS MEANS THE CLOSING DATE HAS BEEN EXTENDED FROM 08 APRIL 2024 TO 23 APRIL 2024 TO ACCOMMODATE THE BRIEFING SESSION ON 11 APRIL 2024 AND GRANT PROSPECTIVE BIDDERS SUFFICIENT TIME TO PREPARE FOR THE DEADLINE.
