



NEW 132/11KV SUBSTATION IN THE DE HOOP AREA, MALMESBURY (PHASE 3) NOTICE T62/22/23

Tenders are hereby invited for contract no: T62/22/23 for phase 3 of a new 20MVA 132/11kV substation in the De Hoop residential area in Malmesbury. The total contract will be executed over two (2) financial years, i.e. 2023/24 and 2024/25.

Tenderers must be registered with the CIDB in an EP Class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers should have a CIDB contractor grading designation of **7EP** or higher.

Tender documents may be obtained from Jo-Marè van der Westhuizen at the Municipal Offices, Swartland Municipality, Kerk Street, Malmesbury. (Tel 022 487 9700). A non-refundable tender fee of **R430.00**, payable in cash, is required on collection of a hard copy of the tender documents. The tender document is available in electronic format on request, at no charge.

Duly completed tenders in sealed envelopes marked "**TENDER T62/22/23: NEW 132/11KV SUBSTATION IN THE DE HOOP AREA, MALMESBURY (PHASE 3)**", together with the name and address of the Tenderer must be placed in the tender box, Municipal Offices, Church Street, Malmesbury before 12:00 on **Friday 14 July 2023**, upon which the tenders will be made public.

A **compulsory clarification meeting** with representatives of the Employer will take place at the Municipal Offices of Swartland Municipality, PEP Building, at the corner of Hill and Piet Retief Street in Malmesbury on **Thursday 22 June 2023, at 11:00. (Registration closes 11:05)**

Late tenders will not be accepted, and the Municipality will not be compelled to accept the lowest or any tender. The Municipality reserves the right to omit any part of the tender. Tenders by telephone, facsimile and e-mail will not be accepted.

Bids will be evaluated in accordance with the Council's Preferential Procurement Policy and the attached specifications. The 90/10-preference point system will be used for the evaluation of the contract. The Preferential Procurement Policy will be available for perusal during normal office hours at the municipal offices. The Swartland Municipality endorses and supports the Government's Black Economic Empowerment Programme and is committed to rectify the inequalities of the past. For bidders to qualify for the advantages of the B-BBEE Act, they must thoroughly complete the attached Annexure MBD 6.1. **There will be no benefits if the schedule is not thoroughly completed. Preference points MUST also be claimed in paragraph 6.1.** Bidders are required to submit **original and valid B-BBEE Status Level Verification Certificates or certified copies** thereof together with their bids, to substantiate their B-BBEE rating claims. **Bidders are also required to submit Proof of Locality in order to claim points for locality.**
