INTRODUCTION

INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, established the National Research Foundation (“NRF”) as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (<https://www.nrf.ac.za>) for more information.

BACKGROUND TO NRF-SAASTA

The South African Agency for Science and Technology Advancement (NRF-SAASTA) is a business unit of the National Research Foundation. NRF-SAASTA’s mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology (SET) in South Africa.

THE REQUIREMENTS OF THIS BID

NRF-SAASTA coordinates a number of science Olympiads and Competitions for learners with the aim of, amongst others, to identify their talent and enhancing their knowledge and understanding of science. This ultimately contributes to their overall engagement and high performance in science.

South Africa is rapidly reaching the forefront of science and technology advancement and has the potential to become a rich source of scientific expertise. This will only be possible if the system is sustained with a healthy supply of learners whose interest in SET is guided by equally passionate educators and learners. It is against this background that NRF-SAASTA’s Science Education Division has a role to contribute through the following strategic objectives:

- Improving learner and educator participation in SET based programmes
- Increasing learner and student exposure to SET based careers

PART A – BID REQUIREMENTS

SPECIFICATIONS FOR EQUIPMENT AND/OR SERVICE REQUIREMENTS

1. Project Brief:

To appoint a panel (including sole proprietors) to set and/or moderate multiple choice questions, memos and solutions and/or translate and/or edit from English to Afrikaans for the categories of the national Olympiads and competitions listed in the table on the first page, for a period of 36 months (3 years) on an “as-and-when-required” basis.

The Olympiads are usually written during the second school term and consists of 100 multiple-choice questions. All the learning topics of the subject have to be covered in the paper. Learners are allowed three hours to write the paper. With the latest developments in response to COVID-19, part of the examination will be written online. A panel of examiners, moderators and translators to set, moderate and translate questions, memos and solutions is required.

SCOPE OF WORK

The multiple choice questions will be set as per the percentages below based on Bloom's Taxonomy. The examiners should indicate exactly which question belongs to which category so that this is clear from the start and the moderator is able to check the questions accordingly. Each question should have one correct answer and three incorrect plausible answers. Each question should also have a solution, e.g. why the correct answer is correct and not any of the other three. The solutions will be used as a training tool after the Olympiad has taken place.

- Remembering – 20%
- Understanding – 30%
- Applying – 30%
- Analysing – 20%
- The Grade 4 – 6 questions will comprise 50% of questions aligned to the CAPS syllabus and 50% of questions beyond. Examiners will be expected to indicate which questions are syllabus based and which are beyond, as well as which questions are based on which grade. The 50% of questions aligned to the CAPS syllabus must be made up as follows:
 - Grade 4 syllabi will make 15% of question set.
 - Grade 5 syllabi will make 20% of question set.
 - Grade 6 syllabi will make 15% of question set.
- The Grade 7 – 9 questions will comprise 50% of questions aligned to the CAPS syllabus and 50% of questions beyond. Examiners will be expected to indicate which questions are syllabus based and which are beyond as well as which questions are based on which grade. The 50% of questions aligned to the CAPS syllabus must be made up as follows:
 - Grade 7 syllabi will make 15% of question set.
 - Grade 8 syllabi will make 20% of question set.
 - Grade 9 syllabi will make 15% of question set.
- The Grade 10 – 12 questions set will comprise 50% of questions aligned to the CAPS syllabus and 50% of questions beyond. Examiners will be expected to indicate which questions are syllabus based and which are beyond as well as which questions are based on which grade. The 50% of questions aligned to the CAPS syllabus must be made up as follows:
 - Grade 10 syllabi will make 15% of question set.
 - Grade 11 syllabi will make 20% of question set.
 - Grade 12 syllabi will make 15% of question set.
- Examiners are expected to:
 - set their own questions, memos and solutions and not to duplicate information from previous question papers according to the stipulated guidelines above
 - set a prescribed set of questions, memos and solutions within the agreed time frames
 - provide high quality pictures/photos/diagrams where applicable. (No pictures/photos/diagrams should pixelate, i.e. should not be blurry.)
 - provide pictures/photos/diagrams, which can be resized and still be visible and legible.(example will be provided upon request)
 - insert labels of any diagram/picture separately in a text box to enable translation, i.e. not scan with diagram/picture.
 - make changes as per the moderator's instructions

- provide data sheets where applicable
- provide questions in Word format in font Arial
- Moderators are to:
 - moderate a prescribed set of questions, memos and solutions within the agreed time frames.
 - moderate a prescribed set of questions, memos and solutions ensuring that these apply to the guidelines as stipulated under the scope of work, thus adhering to the content and cognitive prescriptions
 - make recommendations, changes and provide a report on his/her findings in order for the examiner to make the necessary changes
 - check for scientific correctness of questions
 - check for clarity/correctness of diagrams
 - select the questions from a question bank (if required) according to the requirements for the paper and finally quality assure the paper.
- Translators are to translate and edit questions and solutions within the agreed time frames.

DUE DILIGENCE

NRF-SAASTA wishes to invite suitably experienced service providers to submit proposals for the setting/moderation/translation/editing of examination questions and solutions for NRF-SAASTA national Olympiads and competitions. Submissions should include CVs of the current proposed project team as proof of capacity and capability.

The Company/Sole proprietor profiles should comply with the requirements below:

- A summarised business profile or CV relevant to the project, limited to a **maximum of 10 pages**. Relevant experience should clearly be stated,
- If applying as a company, submit separate CVs of staff who will be responsible as examiners/moderators/translators per the chosen category/subject,
- Indicate whether your application is for examiner, moderator, translator and/or editor,
- List relevant educational qualifications,
- Experience - indicate the number of years of setting/moderating/translating/editing of question papers,
- If you are a sole proprietor, submit a minimum of one relevant contactable reference per each of the subject/category chosen or applying for with whom you have previously worked with;
- If you are a company, provide a minimum of two different and relevant contactable references per each of the subject/category chosen or applying for (from different companies/organisations/individuals not working for the same organisation) with whom you have previously worked with;
- List relevant similar work done in the category you are applying for. Attach evidence in the form of a portfolio of previous similar work done in the category you are applying for (three examples of papers of minimum three pages each, will suffice).

Confidentiality:

The successful bidder undertakes not to share the questions, memos and solutions or any related information with outside parties.

Costings Specifications:

- Quotations will be submitted as and when requested. (The rates indicated in the bid pricing schedule will apply)

- Quotations must be VAT inclusive.

References:

Minimum two (2) contactable references with whom the bidder has done business in the past thirty-six (36) months. Sole proprietors should submit a minimum of one reference.

Ethical requirements

The bidder must confirm that there are no interests with the NRF and its business units, has clean business practises, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 4, SBD 8, and SBD 9 forms. The bidder to provide detailed requirement feedback in order to evaluate the bidder’s ability to deliver on the bid.

Please note that NRF-SAASTA reserves the right to:

- withdraw and cancel the call for Service Providers.
- have the quality of material reviewed according to Scientific Editorial Process (SEP).
- return questions, memos and solutions that might require reworking due to unacceptable quality or standard.
- evaluate the CVs of the team members at any time when the work is assigned.

CONTRACT PERIOD

The contract is for a period of 36 months on an as-and-when required basis

CONTRACT MANAGEMENT

1 Delivery Timing E.g. Lead times

- 1.1 Examiner: Setting of 100 Olympiad/Competition questions, memos and solutions for a relevant category – 30 days
- 1.2 Moderator: Moderation of 100 questions, memos and solutions for a relevant category – 15 working days, i.e. three weeks
- 1.3 Translator and Editor: Translation and editing of 100 questions and solutions from English to Afrikaans – 10 working days
- 1.4 Questions, memos and solutions must be submitted in MS Word format. Note: NRF-SAASTA will provide an example of the layout.
- 1.5 The bidder is to respond to queries from NRF-SAASTA within 24 hours.

2 Procurement of services during the contract

- 2.1 Provide NRF-SAASTA with quotations as and when services are needed

3 Supplier Relationship Management

- 3.1 Meetings (online where applicable) will be held with service provider/s as and when needed.

4 Contract management during implementation

4.1 NRF-SAASTA reserves the right to:

- sign and conclude a formal contract with the successful bidder
- appoint more than one service provider per category
- perform spot checks to ensure that prices are market related.

4.2. If the service provider fails to deliver within the deadlines as specified under the heading “Delivery timing” above, the

service provider will be liable for any costs incurred by NRF-SAASTA to complete the job by a third party.

4.3. General conditions of contract will be applicable to this bid.

4.4. All costs incurred for submission of the invitation to bid is for the bidder's account.

5 Termination of contract due to non-performance

5.1 In the event of the non-performance as per the agreed contract, NRF-SAASTA will appoint an alternative at the cost of the appointed third party. The defaulting third party is obliged to settle the damages/additional costs that NRF-SAASTA has incurred as result of the non-performance of the appointed bidder.

6 Occupational Health and Safety when working on NRF sites:

6.1 All personnel performing work on NRF-SAASTA site/s as part of this contract are responsible to obtain a safety induction.

6.2 Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder is to meet with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.

6.3 The appointed bidder, once having signed the contract (**SBD 7 and the NRF's Section 37.2 agreement**), is responsible for itself, its employees, and those people affected by its operations in terms of the Act and the regulations promulgated in terms thereof. The appointed bidder is to perform all work and to use equipment on site complying with the provisions of the Act.

6.4 To this end, the appointed bidder shall make available to NRF-SAASTA a valid Letter of Good Standing in terms of the COID Act and ensure that its validity does not expire while executing this bid, where applicable. The appointed bidder is to furnish its registration number to the office of the Compensation Commissioner.

6.5 The appointed bidder is to maintain a health and safety plan complying with the requirements of the Act at the work site during the period that contracted work takes place on the site.

6.6 NRF-SAASTA manages the appointed bidder in his capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder accepts liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel) are to submit a signed indemnity form prior to entering the work site and keep it in the appointed bidder's health and safety file.

7 Original bid documents for contract signing

7.1 The set of original bid documents in hard copy format (paper document) serves as the original master set for the legal contract document between the contracting parties. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

8 Managing service levels

8.1 Upon appointment of the bidder, both parties agree on the final set of performance levels for each deliverable service level including measurable key performance indicators with minimum thresholds. This is done in writing and appended to the contract document.

8.2 Where both parties agree to variations of these performance levels, both parties are to sign the revision, which is appended to this contract document.

8.3 The appointed bidder and the NRF-SAASTA contract manager measure the delivered performance against the performance levels agreed on.

8.4 Where either party has identified poor performance under this contract, both parties will meet and investigate

the matter to determine the root cause, the correction plan, and the execution planning thereof.

8.5 Both parties will monitor the corrective actions.

8.6 Both parties will assess the applicability of penalties due to the incurred poor performance and apply these,

GENERAL AND SPECIAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, the word "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	"Day" means calendar day.
1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	"GCC" mean the General Conditions of Contract.
1.15	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	"Local content" means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.
1.18	"Manufacture" means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
1.19	"Order" means an official written order issued for the supply of goods or works or the rendering of a service.
1.20	"Project site", where applicable, means the place indicated in bidding documents.
1.21	"Purchaser" means the organization purchasing the goods.
1.22	"Republic" means the Republic of South Africa.
1.23	"SCC" means the Special Conditions of Contract.
1.24	"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
GCC 5	Use of contract documents and information
5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.

As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

23.2	In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
23.3	Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
23.4	If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.
23.5	Any restriction imposed on any person by the Accounting Authority will, at the discretion of the Accounting Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Authority actively associated.
23.6	If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information: 23.6.1 the name and address of the supplier and / or person restricted by the purchaser; 23.6.2 the date of commencement of the restriction 23.6.3 the period of restriction; and 23.6.4 the reasons for the restriction. GCC26	Termination for insolvency

In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
GCC27	Settlement of disputes
