Responses to this **RFQ 10334364/LH/TF/10/2022** must not include documents or reference relating to any other quotation or proposal. Any additional conditions must be embodied in an accompanying letter.

Proposals must reach the PRASA before the closing hour on the date shown on SBD1 above, and must be enclosed in a sealed envelope.

#### 2. PREQUALIFICATION / ELIGIBILITY CRITERIA

2.1 Only those Respondents who satisfy the following pre-qualification or eligibility criteria are eligible to submit quotations as per section 3.

#### 3 CIDB Grading

Only those Respondents who are registered with the CIDB, or are capable of being so prior to the submission of the quotation, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a .....class of construction works, are eligible to have their quotations evaluated.

Joint ventures are eligible to submit tenders provided that:

- every member of the joint venture is registered with an active CIDB;
- the lead partner has a higher or equivalent contractor active grading designation in the class of construction work; and
- the combined Contractor active grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a Contractor grading designation determined in accordance with the sum quoted for a **4SH or higher** class of construction works or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations

#### 4 COMMUNICATION

Respondent/s are warned that a response will be liable for disqualification should any attempt be made either directly or indirectly to canvass any SCM Officer(s) or PRASA employee in respect of this RFQ between the closing date and the date of the award of the business.

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

All prices must be quoted in South African Rand on a fixed price basis, including VAT.

## **8 BINDING OFFER**

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

## **9 DISCLAIMERS**

PRASA is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that PRASA reserves the right to:

- Modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- Reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- Disqualify Quotations submitted after the stated submission deadline;
- Not necessarily accept the lowest priced Quotation or an alternative bid;
- Bids lodged at the incorrect venue that reach the correct venue late will be regarded as late.
- Reject all Quotations, if it so decides;
- Place an order in connection with this Quotation at any time after the RFQ's closing date;
- Make no award at all.
- Award only a portion of the proposed goods / service/s which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider should it at PRASA's discretion be more advantageous in terms of, amongst others, cost or developmental consideration; or

## **10 LEGAL REVIEW**

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by PRASA's Legal Counsel, prior to consideration for an award of business.

## **11 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE**

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. PRASA is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. ## **12 PROTECTION OF PERSONAL DATA**

In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. PRASA agrees that it shall only process the information disclosed by Respondents in their response to this bid for the purpose of evaluating and subsequent award of business and in accordance with any applicable law.

Furthermore, PRASA will not otherwise modify, amend or alter any personal data submitted by Respondents or disclose or permit the disclosure of any personal data to any Third Party without the prior written consent from the Respondents. Similarly, PRASA requires Respondents to process any personal information disclosed by PRASA in the bidding process in the same manner.

### 14 ADMINISTRATIVE RESPONSIVENESS

The test for administrative responsiveness will include completeness of response and whether all returnable and/or required documents, certificates; verify completeness of warranties and other bid requirements and formalities have been complied with. Incomplete Bids will be disqualified.

### 15 VALIDITY PERIOD

- 15.1 PRASA requires a validity period of **60 Business Days** from the closing date.
- 15.2 Respondents are to note that they may be requested to extend the validity period of their response, on the same terms and conditions, if the internal processes are not finalized within the validity period. However, once the adjudication body has approved the process and award of the business to the successful



respondent(s), the validity of the successful respondent(s)' response will be deemed to remain valid until a final contract has been concluded.

## SECTION 5

### PRASA GENERAL CONDITIONS OF PURCHASE

#### General

PRASA and the Supplier enter into an order/contract on these conditions to supply the items (goods/services/works) as described in the order/contract.

#### Conditions

These conditions form the basis of the contract between PRASA and the Supplier. Notwithstanding anything to the contrary in any document issued or sent by the Supplier, these conditions apply except as expressly agreed in writing by PRASA.

No servant or agent of PRASA has authority to vary these conditions orally. These general conditions of purchase are subject to such further special conditions as may be prescribed in writing by PRASA in the order/contract.

#### Local Content Obligations

Respondents are to note that the Local Content commitments made by the successful Respondent(s) will be incorporated as a term of the contract and monitored for compliance. Should the successful Respondent fail to meet its Local obligations, non-compliance penalties shall be applicable. Breach of Local Content obligations also provide PRASA cause to terminate the contract in certain cases where material non-compliance with Local Content requirements are not achieved.

#### Price and payment

The price or rates for the items stated in the order/contract may include an amount for price adjustment, which is calculated in accordance with the formula stated in the order/contract.

The Supplier may be paid in one currency other than South African Rand. Only one exchange rate is used to convert from this currency to South African Rand. Payment to the Supplier in this currency other than South African Rand, does not exceed the amounts stated in the order/contract. PRASA pays for the item within 30 days of receipt of the Suppliers correct tax invoice.

#### Delivery and documents

The Supplier's obligation is to deliver the items on or before the date stated in the order/contract. Late deliveries or late completion of the items may be subject to a penalty if this is imposed in the order/contract. No payment is made if the Supplier does not provide the item as stated in order/contract.

Where items are to be delivered the Supplier:

- Cutting and edging of lawns.
- Trimming of hedges, branches, and trees.
- Cultivating of beds.
- All grass cuttings and trimmed branches shall be removed from the site.
- All fuel and maintenance of machinery must be supplied.

## **Weeding**

Weeds must be removed on the pavement, flower beds and driveways, by also using Chemical spot applications of an approved herbicide. Herbicides shall only be applied in accordance with the manufacturer's instructions.

## **Spraying and Fertilizing**

- Spraying of hard surfaces using weed poison.
- Spraying of weeds will be done twice per month, this must be an on-going action with preventative control being executed on lawn areas where and when necessary.
- Supply of fertilizer for the beddings and lawn, this should take place twice per annum.
- Supply of lawn dressing.

## **General Plant Care**

- All grounds and gardens will be weeded on a continual basis.
- General pruning, trimming of hedges, shrubs and trees will take place as required,
- Dead heading of shrubs and groundcovers.
- Sweeping and raking of all areas adjacent to garden areas.

## **Trees/Scrubs**

- All Heights tree Felling services will be required to cut, shape, and remove all debris using chainsaw.
- This should be carried out in accordance with good tree care practices.

## **Dumping**

- Ensure proper disposal of garden rubbish to an authorised dumping site.

## **Watering and Irrigation**

- Hand watering will take place should it be required.
- Repairs of irrigation system and the maintenance of the current system.

## **2. Service Expectations**

- The Contractor shall remove, sweep off and clean up debris or waste resulting from vegetation control activity and shall dump such waste thereafter as indicated. All cleared vegetation and waste accumulated from vegetation clearing shall be disposed to the appropriate and approved waste disposal site.
- “Pruning and removal of vegetation” shall comprise of pruning or trimming of vegetation other than grass cutting in places where such vegetation maybe hanging over loose, e.g., over electrical poles, over the fence, or obstructing property, signage.
- The contractor shall ensure that the areas shall be cleared **2 metres** from the perimeter fence

and/or building structure and shall always be cleared for the full perimeter fence and/or building area.

- The areas to be maintained will be measured and determined before the execution of each intervention. The Contractor and the Project Manager/Technical Officer shall arrange the site inspection to confirm the areas to be maintained prior to commencement of work.
- The Contractor shall furnish PRASA CRES, **Facilities Department** with a copy of site disposal certificate after disposal of waste.
- All services shall be on AS and When required basis.
- All work will be carried out during normal working hours at the rates tendered for in the Pricing schedule. Visits to the premises will be as scheduled for the contractor to carry out maintenance work as per the specification. Sites have visitors book which is to be properly completed by the Contractor on every visit and the reason for the visit recorded in the book.
- PRASA-CRES reserves the right to conduct an independent safety and quality audit to be carried out on the work completed by the contractor. The contractor shall provide his own quality controls to ensure compliance with the specifications and any changes to legislation or regulations applicable. CRES for consideration.
- The Contractor must ensure that all vehicles, plant & equipment to be used on site and in the PRASA sites are kept and maintained in good condition and working order.
- The contractor shall be or have in his employment qualified personnel to operate machinery, equipment and have knowledge using tools required for the work.
- **Labour** – The bidder shall provide PRASA CRES with **one (1) Supervisor** and at least **fifteen (15) gardening technicians** on site; and this ***staff compliment need be maintained throughout the contract duration*** As and When the service is required.

### **3. Safety**

---

The Contractors' Staff and Labourers to be used on site must:

- Be inducted by the PRASA SHE Department before working on site
- Protective Clothing: The contractor shall provide all forms of safety and protective clothing for their personnel. The clothing shall also clearly indicate the name of the Company on it in large and clear letters so that the public can clearly identify the Company if need be. Full Personal Protective Equipment (PPE) shall be worn whenever vegetation management work is performed.

## 4. Compliance

---

The Contractor shall always ensure that work is performed in accordance with all the prescribed legal prescripts.

- **NB:** No work shall be performed on site without approval of Safety File and valid signed site access certificate being issued to the contractor.
- **Response time** – if an appointed service provider as per the General provisions of the As and When fails to adhere to the priority levels as prescribed PRASA CRES Facilities department hereby reserves the right to penalise the service provider a penalty fee of 10% of the value of the work and if this provision is continually being violated the contract will be terminated.
- **Proof of Work done**> the contractor will provide photos of before/during and after work completed with claim submitted. Photos can be submitted electronically.
