Wheelbarrows are used in the tunnels and glasshouses to move plants in growth bags from one site to another. Wheelbarrows are also used to transport sand, Hygromix and other potting soil. Wheelbarrows should be the narrow type, because personnel should be able to move them inbetween cement throughs in the tunnels. Plants from various grapevine breeding projects are grown in the tunnels and glasshouses. Projects P04000045 (table grape breeding), P04000058 (wine grape breeding) and P04000060 (Pinotage mutation) receive funding from the grapevine industries.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
