1. PURPOSE

The purpose of this RFQ is to appoint a consultant to provide technical support in the form of conducting biodiversity site assessments, developing property operational plans and to conduct training on biodiversity site assessments and the SANParks contract national park guideline. This technical support will provide capacity to support the implementation of the Land Inclusion Policy the Land Inclusion Plan and the 2023/2024 SANParks Annual Performance Plan.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

SANParks' operations are guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

SANParks aims to expand the system of National Parks in accordance with the SANParks Board approved Land Inclusion Plan. The National Environmental Management Protected Areas Act, Act 57 of 2003 provides SANParks with several mechanisms for expanding the system of national parks. These include the declaration of land that is purchased by SANParks, or land owned by the state, land held in trust by the state on behalf of communities, and privately owned land. A cost-effective approach to ensure SANParks meets its expansion targets is through the declaration of private land as a new national park or as part of an existing national park.

A Contract National Park is an area of privately or communally owned land that is declared as a National Park under the Protected Areas Act. The land remains the property of the owner, but it is managed by way of a written agreement between SANParks and the landowner.

There has been an increase in landowners interested in the contract national park option for their private land around existing National Parks. SANParks requires additional capacity to implement the Land Inclusion Policy the Land Inclusion Plan and the 2023/2024 SANParks Annual Performance Plan.

3. SCOPE OF WORK

SANParks seeks to contract a consultant to provide technical support for contract national park land inclusion and land purchase. The initial key outputs will be:

1. Using the SANParks site assessment form:
 - 1.1 Conduct desk top biodiversity site assessments (5 days)
 - 1.2 Conduct biodiversity site assessments in the field (40 days)
2. Using the SANParks property operational plan template:
 - 2.1 Develop property operational plans for contract national park properties (15 days)
 - 2.2 Develop a schedule of management actions for identified properties (4 days)
 - 2.3 Support with the development of a land use map for identified properties (4 days)
3. Technical support for land purchase applications (5 days)
4. Conduct training and capacity building on:
 - 4.1 Conducting biodiversity site assessments in field (6 days)
 - 4.2 Training on the contract national park guideline (6 days)

Reporting requirements & Management

- The service provider will be working with SANParks personnel as well as with individuals or teams from other organisations as well as landowners and communities
- Accountability and reporting will be to the GM: Park Planning and Development.
- All reports must be in MS Office format (Word or Excel preferred).
- An electronic version of all reports & models must be submitted.

Duration

It is anticipated that the assignment will run for a period of 18 months from contracting. It is expected that the time required for this initial work is 85 full day's work.

Note:

1. The SANParks template for biodiversity site assessments is available for use.
2. The Contract National Park Guideline is in the process of being completed and is available for the training session.

3. *Travel costs should not be included in the costing*

Service providers interested in contributing towards this work should submit a concise written proposal that addresses the scope of work and the below requirements and outputs.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
