## 1. PURPOSE

The purpose of these terms of reference (TOR) is to invite bidders to submit a quotation for the appointment of a service provider to provide pest control services in Groenkloof National Parks for a period of 5 years

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## 3. SCOPE OF WORK

### Specification of the Pest Control is as follows,

Any person who for reward or in the course of a business, industry or trade uses an agricultural remedy must register as a Pest Control Operator (PCO) in terms of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act No. 36 of 1947) as amended and the regulations relating thereto as published in Government Notice No. R1449 of 1 July 1983.

- Office fumigations services two times per annum.
- Spray and gel all the offices for ants, termites, mosquitoes and cockroaches
- Spray and gel all 19 kitchens and 1 cafeteria for ants, termites and cockroaches bimonthly
- Submit treatment report per each services

Measures of performance will be further stipulated and agreed in the Service Level Agreement and be based on the following principles:

- i) Bimonthly inspections treatment report
- ii) Call – Outs and complain responding (Re-active Respond to complain):
- iii) One free call out between service intervals

### 5.3 FUNCTIONALITY REQUIREMENTS

SANParks promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team. The minimum functional threshold will be **70%**.

Any bidder who does not meet the minimum threshold will not proceed to the Price and Preference Stage of evaluation.

## 6. CENTRAL SUPPLIER DATABASE INFORMATION

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury. Failure to submit the requested information may lead to disqualification. (Please provide proof of registration on the Central Supplier Database).

## 7. SPECIAL CONDITIONS

- All chemicals must be SABS approved and safe for human occupation after spraying, proof to be submitted
- Supplier will be required to use non-pesticide methods of control whenever possible, neither sticky traps nor mousetraps to be used.
- Any person who for reward or in the course of a business, industry or trade uses an agricultural remedy must register as a Pest Control Operator (PCO) in terms of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act No. 36 of 1947) as amended and the regulations relating thereto as published in Government Notice No. R1449 of 1 July 1983.
- The applicant must comply with at least one of the following requirements in accordance with the abovementioned regulations:
  - Regulation 2(3) (b): The National Certificate in Pest Control must be obtained;
  - Regulation 2(3) (c): Has successfully completed a course of instruction which the Registrar recognizes and has administered agricultural remedies for at least six months under the supervision of a registered Pest Control Operator. Experience must be substantiated by a sworn affidavit;
  - Regulation 2(3) (d): In the course of a business, in the presence and under the supervision of a Registered Pest Control Operator, has administered agricultural remedies continuously for four years. Experience must be substantiated by a sworn affidavit.
  - The pest control services are to in line with standard stipulated in the South African Pest Control Association (SAPCA) / Pest Control Service Industries Board (PCSIB)

## 8. EVALUATION CRITERIA AND WEIGHTING

The RFQ stipulated that the responses to be evaluated using the 80/20 preference points system in accordance with the PPPFA guidelines. Based on this system the points will be allocated as follows:

## 9. EVALUATION FORMULA FOR PRICE

The following formula will be applied to calculate the scores:

### Price Formula

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

## **12. FINANCIAL PAYMENT**

Payment will be made in accordance to the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

## **13. FINAL AWARD**

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).
