Eskom employees not involved in this tender are not allowed to contact employees involved in this tender or provide information about the tender to potential tenderers.

Should one or more of the top six (6) contractors have a maximum of four (4) teams, the scope for the Kimberley CLN will be rotated amongst the suppliers that meet this requirement.


Each CLN in the Western Grid requires a minimum of two (2) teams to be able to execute the required service except for Kimberly which needs four (4) teams due to the magnitude of the area. The table below is an indication of the CLNs and the number of teams required;
