1. BACKGROUND TO THE PROJECT

The South African Health Products Regulatory Authority (SAHPRA) is schedule 3A independent public entity tasked with regulating (monitoring, evaluating, investigating, inspecting and registering) all health products. This includes clinical trials, complementary medicines, medical devices and in vitro diagnostics (IVDs).

SAHPRA came into existence as of February 2018, effectively replacing the Medicines Control Council (MCC) as the medicine regulator in the country. SAHPRA also took over the functions previously performed by the Directorate of Radiation Control which was under the Department of Health. SAHPRA is required to have a laboratory to test small molecules.

2. PURPOSE

SAHPRA seeks to appoint an experienced technical consultant (specialising in laboratory operations i.e chemical, microbiological, pharmaceutical, medical or forensic labs) who will provide advice on the most feasible laboratory option for SAHPRA.

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
