SCOPE OF WORKS AND SPECIAL CONDITIONS OF CONTRACT

ThembeSile Hani Local Municipality hereby invites bidders from suitably qualified service providers for the **APPOINTMENT OF A PANEL OF SERVICE PROVIDERS TO PROVIDE ASSISTANCE IN HANDLING EVICTIONS AND RELOCATIONS TO COUNTER LAND INVASIONS AS AND WHEN REQUIRED FOR A PERIOD OF 36 MONTHS.**

The Service Providers will be appointed herein for the provision of assistance in handling evictions and relocation, patrols to counter land invasions and relocations and other related matters thereto in ThembeSile Hani Local Municipality.

1. **EMPLOYER'S OBJECTIVES**

The employer's objective is to respond on the issue of land invasion within its area of jurisdiction.

2. **OVERVIEW OF THE WORKS**

The service PROVIDERS will be assisting the municipality with handling evictions and relocation to counter land invasion.

3. **EXTENT OF THE WORKS**

The service PROVIDERS is intended for a period of 36 Months and will provide as and when required services and support to the Planning and Economic Development Department on handling evictions and relocations to counter land invasions. The department is responsible for an array of eviction work and the scope of the contract will encompass two broad categories namely, eviction and Monitoring. These categories are further categorised as follows:

### **3.1 Assist with Evictions.**

- Assist with serving carrying out eviction notices through sheriff.
- Assist in serving municipal contravention notices.
- Assist with demolition of complete permanent structure.
- Assist with demolition of incomplete structure.

### **3.2 Removal of Building Material, Rubble and Dangerous Trees.**

- Removal re-usable materials from the site to the storage.
- Removal of rubble and other material on site to a legal waste disposal site.
- Cutting and removal of tree branches to a legal waste disposal site.
- Uprooting the trees stumps with girth of 250 mm to 1m average-all roots removed.

### **3.3 Monitoring/Patrolling/Whistle Blowing As and When required.**

- Inspect/Patrol on an identified informal settlements and vacant areas within identified ward.
- Informal Settlement Officer.
- Grade C Security Officer in full uniform with the company's insignia on shoulder flashes.
- Supervisor in full uniform with the company's insignia on shoulder flashes and with cell phone and camera.

### **3.4 Backfilling of Dangerous Holes on Site.**

- Backfilling dangerous holes and pit latrines on site.

### **3.5 Compiling Data.**

- Conduct survey and complete documentation.
- Data Capturing.
- Numbering structures with a paint.
- Aerial photographs and video captured by drone.

### **3.6 Dismantling and Relocation of Structures.**

- Dismantle temporary structure.
- Dismantle and removal of stands demarcation poles.
- Transport re-usable building material, household contents and family to resettlement area.
- Transporting materials removed to the municipal storage.

## **4. LOCATION OF THE WORKS**

The work will be done within Nkangala District Municipality in Mpumalanga province and it falls under Thembeisile Hani Local Municipality as and when required. The eviction will depend
