DTPC hereby invites proposals for the **appointment of a contractor for the construction of additional ablutions and skirting to the existing TradeZone 1, Mini factories for Dube TradePort.**

The work includes, but is not limited to the following:

- Construction of additional ablutions.
- Supply, manufacture, including powder coating Aluminium Skirting.
- Testing and Commissioning.

It is estimated that tenderers must have an active **CIDB grading of 3GB or higher** by the closing date of the bid. **No Potential Emerging (PE) status is allowed.**

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

- 10 points will be allocated to enterprises who are located in KZN
- 10 points will be allocated to enterprises who are EME
