1. INTRODUCTION AND PURPOSE

A quotation to appoint a service contractor for the repairs of a traffic signal at a corner of Waltloo Road & Tsamaya Street

2. BACKGROUND

Background detail of the bid:

The intersection affected is one of the intersections used as main entry into Mamelodi area. Vandalized beyond normal repairs. The objective of the repairs is reinstate the signalized intersection to operation to reduce current delays experienced on site. The repairs to be funded under Roads & Transport Department, Transportation & Planning Division, Traffic Signal Subsection, under the Cost Centre 2565, GL4035270024, funded by the CoT.

The service provider will not be required to obtain a wayleave for the works, the subsection will apply for necessary permits required for the repairs on site on behalf of the service provider.

The restatement of the signal will provide direct benefit to the community of Mamelodi as it will provide a better controlled intersections, therefore reducing current traffic delays experienced at this intersection.

The technical process, the project management for the reinstatement of the signal at the corner of Tsamaya / Waltloo will be monitored and managed by the CoT officials from the traffic signals subsections.

3. PROJECT SCOPE

The general scope of works for signal repairs onsite consist of the following, not all items will be required as per description below;

3.1) Ancillary work on site

The service provider shall provide day to day traffic accommodation during construction on site, and provide a weekly safety report in a file form to the CoT as OHS procedures.

3.2) Ducting & Earthworks

The service provider to provide 110mm black ribbed PVC flex ducting for channelling cables below the road surface. All excavation to be conducted by manually by hand. Soil material excavated to be back filled and compacted. Excess material to be removed from site to a dedicated dumping site.

Manhole to be filled with soilcrete to prevent further theft of cable from signalized intersections, and manhole lids to be lowered 200mm below road surface.

3.3) Pedestrian Ramps

The scope does not require ramps, and not to be included as part of the services.

3.4) Block Paving works

60mm Segmented Block back paving will have to be removed during cabling and to be reinstated back to its original point on site.

3.5) Kerbing & Channelling

The scope does not require kerbing work, and not to be included as part of the services.

3.6) Roads Signs (Signal Type)

The service provider must supply and install ST1 and ST2 on signal heads. The signs must be the cromadek type.

3.7) Road/Intersections Markings

The scope does not require intersection marking, and not to be included as part of the services.

3.8) The service provider must supply and install ST1 and ST2 on signal heads. The signs must be the cromadek type.

3.9) Preliminary work

The service provider will be required to trace existing ducts in order to replace old duct with new required ones. No relocation of signal cables will be required.

3.10) Concrete Footing for Signals Poles & Concrete works

The scope does not require concrete footing works as current footing are still intact, and not to be included as part of the services.

3.11) Supply & Erection of Poles

The service provider will be required to supply and erect new poles on site. Those poles will include Standard poles, Overhead poles, Totem poles, and cantilever poles. Poles to be supplied already painted with paint specification below;

Service provider will be required to supply and install different copper cables on site, all copper cable to be SANS approved...See below table

3.13) Supply & Installation of signal heads

Service provider will be required to supply and install signal heads on site, as the current ones on site have been damaged. All the signal Heads must be **SANS 1459:2004 or later** approved. A SANS certificate from the manufacturer of LED signal to be provided as part of the submission by the Service provider. Failure to provide such certification on LED signal heads will lead to the quote being disqualified.

3.14) Supply & Installation of pole top connectors, pedestrian button and earth spikes

The scope does not require pole top connectors, pedestrian buttons and earth spikes, and not to be included as part of the services.

3.15) Supply & Installation of vehicle detection

The scope does not require installation of vehicle detection, and not to be included as part of the services.

3.16) Erection of controller footing and controller cabinet

The service provider will be required to supply and install a traffic controller on site(8-phase, Automotor UA) . The controller to be housed in a none destructive box to be also provided by the service provider onsite. The none destructive box to be housed be fixed on concrete base. See detail on the drawings provided.

3.17) Connection and commissioning

The service provided will be required to connect all electrical cables required to the controller cabinet, main power supply, test all connections, test all conflicts, provide a software configuration of the traffic controller on site, Issue Certificate of Compliance (CoC)

4. DELIVERABLES

The successful bidder must submit the following as part of the project deliverables;

- 4.1) Works program limited to 60 days of work, weekends may be included. Dates and weekly deliverables must be clearly indicated on the program.
- 4.2) Weekly reports on Occupational Health and Safety file from site to be handed to CoT
- 4.3) A fully and functional traffic signal after 60 days to the CoT traffic signal subsection.

5. VALIDITY PERIOD

The validity period for the tender after closure is **90 days**.

- 6.2.2 List of Traffic signals Intersection commissioned by bidder in the past 3 years only, the list must be in official letter written from the client, signed by the client responsible for the service requested. *(minimum of 6xsignalized intersections to Qualify)*
- 6.2.3 Copy of Certificate of Completions on those intersection listed.

Failure to provide all required documents listed in 6.2.1, 6.2.2, and 6.2.3 will lead to immediate disqualification.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
